Remarks

Pursuant to the Scheme of Amalgamation and Arrangement between Ashima Dyecot Private Limited (“Transferor Company”) and Ashima Limited (“Transferee Company”) as approved by the Hon’ble National Company Law Tribunal, Ahmedabad Bench vide its order dated 22nd July, 2020, 7,52,81,959 equity Shares of Rs. 10/- each of the Company held by Ashima Dyecot Private Limited (Promoter), the Transferor Company shall stand cancelled without any further act or deed by operation of law and shall not amount to reduction of paid up share capital in terms of the said Scheme.

Further, in terms of the aforesaid Scheme, the Board of Directors of the Company in the meeting held on 11.09.2020, allotted 13,84,88,161 fully paid up equity shares of Rs. 10/- each to the shareholders of the Transferor Company whose names are recorded in the Register of Members of Ashima Dyecot Pvt. Ltd. as on Record Date i.e. 29th July 2020.

However, since the application of listing Approval with stock exchanges and Corporate Actions with the Depositories are under process, effect of the aforesaid transaction viz. cancellation of shares and allotment of shares have not been shown in the shareholding pattern as on 30.09.2020.
