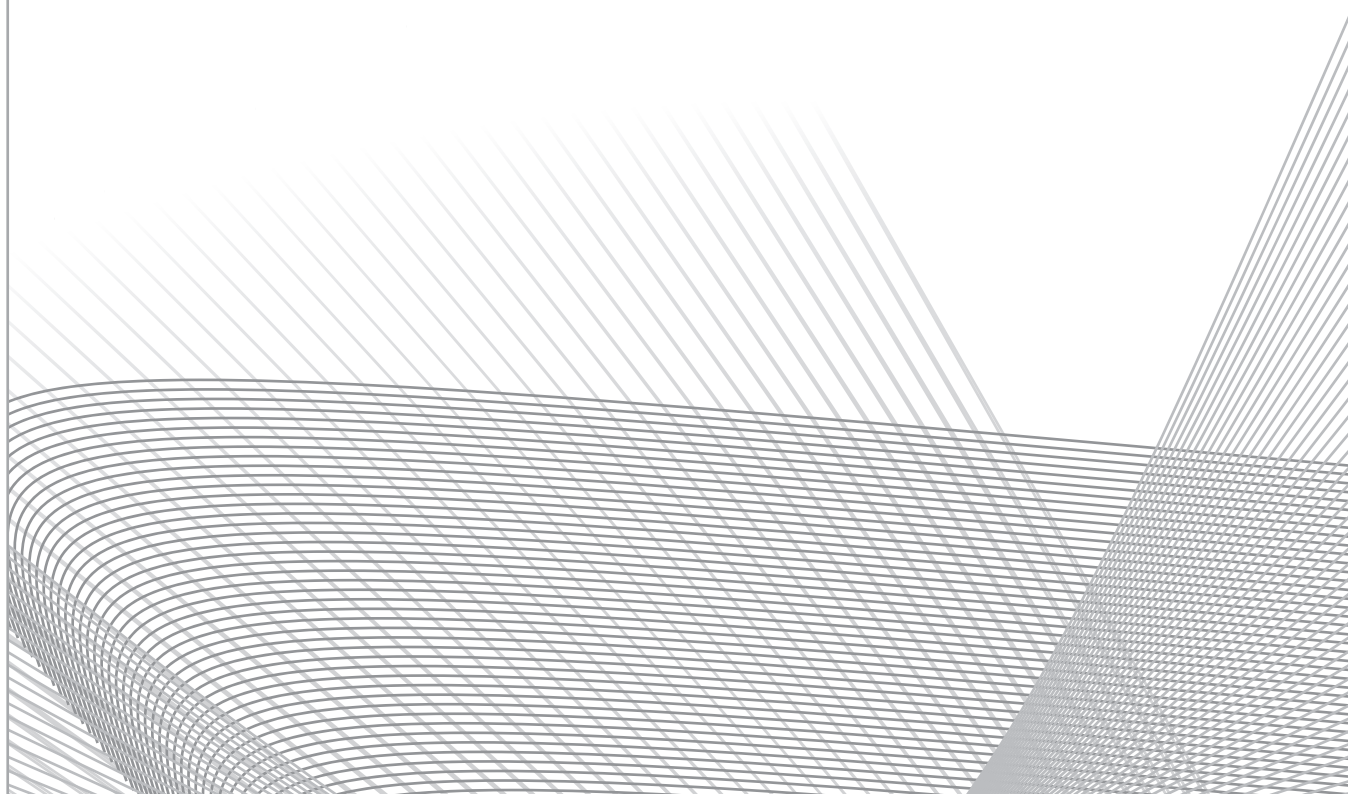

1. To receive, consider and adopt
  - a) the Audited Standalone Financial Statements of the Company for the Financial Year ended March 31, 2026 and the Reports of the Board of Directors and the Auditors thereon; and
  - b) the Audited Consolidated Financial Statements of the Company for the Financial Year ended March 31, 2026 and the Report of the Auditors thereon.

1. The Explanatory Statement pursuant to Section 102 of the Companies Act, 2013, in respect of the Special Business(es) forming part of the accompanying Notice is annexed hereto and forms an integral part of this Notice.
2. The Ministry of Corporate Affairs, Government of India ("MCA") has vide its General Circular 14/2020 dated April 8, 2020, General Circular No. 17/2020 dated April 13, 2020, General Circular No. 20/2020 dated May 5, 2020, General Circular No. 02/2021 dated January 13, 2021, General Circular No. 02/2022 dated May 5, 2022, General Circular No. 10/2022 dated December 28, 2022 and General Circular No. 9/2023 dated September 25, 2023, General Circular No. 9/2024 dated September 19, 2024 and General Circular No. 03/2025 dated September 22, 2025 (collectively referred to as "MCA Circulars") permitted the holding of the Annual General Meeting ("AGM" or "Meeting") through Video Conferencing facility/ Other Audio Visual Means ("VC/OAVM") without the physical presence of the Members at a common venue. Accordingly, the 43rd AGM of the Company is being held through VC/OAVM.  
  
Securities and Exchange Board of India ("SEBI") vide its circular no. circular no. SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated May 12, 2020, SEBI Circular No. SEBI/HO/CFD/CMD2/CIR/P/2021/11 dated January 15, 2021, SEBI Circular No. SEBI/HO/CFD/CMD2/CIR/P/2022/62 dated May 13, 2022, SEBI Circular No. SEBI/HO/CFD/PoD-2/P/CIR/2023/4 dated January 5, 2023 and SEBI vide its Circular No. SEBI/HO/CFD/CFD-PoD-2/P/CIR/2023/167 dated October 7, 2023 and SEBI/HO/CFD/CFD-PoD-2/P/CIR/2024/133 dated October 3, 2024 provided relaxation from Regulation 36 (1) (b) of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015 ("LODR Regulations") regarding sending hard copy of annual report containing salient features of all the documents prescribed under Section 136 of the Companies Act, 2013 to the shareholders who have not registered their email addresses and also dispensed with the requirement of sending proxy forms under Regulation 44(4) of the LODR Regulations in case of Annual General Meetings held through electronic mode only.
3. In line with the aforesaid MCA Circulars and SEBI Circulars, the Notice of AGM ("Notice") along with Annual Report for the financial year 2025-26 shall be sent only through electronic mode to those members whose email IDs are registered with the Company/depository participant(s). Members may note that Notice and Annual Report for 2025-26 has been uploaded on the website of the Company at [www.ashima.in](http://www.ashima.in). Notice and Annual Report can also be accessed from the websites of the Stock Exchanges i.e. BSE Limited and National Stock Exchange of India Limited at [www.bseindia.com](http://www.bseindia.com) and [www.nseindia.com](http://www.nseindia.com) respectively and the AGM Notice is also available on the website of CDSL (agency for providing the Remote e-voting facility) i.e. [www.evotingindia.com](http://www.evotingindia.com).
4. The attendance of the Members attending the AGM through VC/OAVM will be counted for the purpose of reckoning the quorum under Section 103 of the Companies Act, 2013.
5. Corporate Members are encouraged to attend the AGM through their Authorized Representatives. They are requested to send by email a certified copy of the Board Resolution/ Authorisation Letter authorizing their representatives to attend and vote on their behalf in the Meeting. The said Resolution / Authorisation letter shall be sent to the Scrutinizer by email through its registered email address to [scrutinizer@tapan.shah.in](mailto:scrutinizer@tapan.shah.in) or [investor\\_redressal@ashima.in](mailto:investor_redressal@ashima.in) with a copy marked to [helpdesk.evoting@cdslindia.com](mailto:helpdesk.evoting@cdslindia.com).
6. Since the AGM is being held through VC /OAVM in accordance with the aforesaid Circulars, the facility to appoint proxy to attend and cast vote for the members is not available for this AGM and hence the Proxy Form, Attendance Slip and Route Map are not annexed to this Notice. However, the Body Corporates are entitled to appoint authorised representatives to attend the AGM through VC/OAVM and participate thereat and cast their votes through e-voting.
7. Members holding shares in physical form are requested to intimate any change of address and / or bank mandate to MUFG Intime India Private Limited (formerly known as Link Intime India Pvt. Ltd.) or Secretarial Department of the Company immediately. In case shares are held in dematerialized



form, the information regarding change of address and bank particulars should be given to their respective Depository Participant.

8. The Register of Directors and Key Managerial Personnel and their shareholding maintained under Section 170 of the Companies Act, 2013, the Register of contracts or arrangements in which the Directors are interested under Section 189 of the Companies Act, 2013 and all other documents referred to in the Notice will be available for inspection in electronic mode.
  9. The Members can join the AGM through the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the AGM through VC / OAVM will be made available for 1,000 members on first come first served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc., who are allowed to attend the AGM without restriction on account of first come first served basis.
  10. The Company has sent individual letters to all the Members holding shares of the Company in physical form for furnishing their PAN, KYC details and Nomination. The aforesaid communication is also available on the website of the Company. Attention of the Members holding shares of the Company in physical form is invited to the said important communication under the weblink at <https://ashima.in/wp-content/uploads/2023/04/Shareholders-holding-shares-in-physical-form.pdf>.
  11. **INSTRUCTIONS FOR REMOTE E-VOTING AND E-VOTING DURING AGM AND JOINING MEETING THROUGH VC/OAVM ARE AS UNDER:**
    - i. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 (as amended), and the aforesaid MCA Circulars and SEBI Circulars, the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the AGM. For this purpose, the Company has entered into an agreement with Central Depository Services (India) Limited (CDSL), as the Authorised e-voting agency for facilitating voting through electronic means. The facility of casting votes by a member using remote e-voting as well as e-voting system on the date of the AGM will be provided by CDSL.
    - ii. Members whose names are recorded in the Register of Members or in the Register of Beneficial Owners maintained by the Depositories as on the cut-off date i.e. Thursday, July 30, 2026, shall be entitled to avail the facility of remote e-voting as well as e-voting system on the date of the AGM. Any recipient of the Notice, who has no voting rights as on the cut-off date, shall treat this Notice as intimation only.
    - iii. A person who has acquired the shares and has become a member of the Company after the dispatch of the Notice of the AGM and prior to the cut-off date i.e. Thursday, July 30, 2026, shall be entitled to exercise his/her vote either electronically i.e. remote e-voting or e-voting system on the date of the AGM by following the procedure mentioned in this part.
    - iv. The remote e-voting will commence on Monday, August 03, 2026 at 9:00 a.m. and will end on Wednesday, August 05, 2026 at 5:00 p.m. During this period, the Members of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date, may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter. Once the vote on the resolution is cast by the Member, he/she shall not be allowed to change it subsequently or cast vote again.
    - v. Shareholders who have already voted prior to the meeting date would not be entitled to vote during the meeting.
    - vi. The voting rights of the members shall be in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date.

- vii. The Company has appointed Mr. Tapan Shah, Practising Company Secretary (Membership No. FCS: 4476; CP No: 2839), to act as the Scrutinizer for conducting the remote e-voting process as well as the e-voting system on the date of the AGM, in a fair and transparent manner.
- viii. In terms of SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020 on e-voting facility provided by listed companies, individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-voting facility.

Brief profile and other details of Ms. Uttara Chintan Parikh, pursuant to the provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and Secretarial Standard-2 on General Meetings, issued by the Institute of Company Secretaries of India, are provided in the Annexure to this Notice.

Considering the expertise of Non-Executive Directors (including Independent Director) of the Company, time spent, efforts made and their contribution to the Company and responsibility for Corporate Governance, on the recommendation of Nomination and Remuneration Committee, the Board of Directors of the Company has, at its meeting held on May 23, 2026, approved the payment of yearly commission/remuneration of ₹ 3,00,000/- (Rupees Three Lac only) to each Non-Executive Director (including Independent Director) of the Company, in addition to sitting fees and other expenses being paid to them for attending the meetings of the Board and its committees, subject to the permissible limit applicable to the Company under the provisions of the Companies Act, 2013.

Further, pursuant to Section 197 of the Act and Schedule V, in the event of absence or inadequacy of profits (as calculated under Section 198 the Act) in any financial year, the Company can pay a managerial remuneration to its Directors including any Whole-time Director or any Non-executive Director, including any Independent Director, a sum not exceeding the limits prescribed under said Schedule V subject to the following conditions:

**CHAIRMAN'S MESSAGE TO SHAREHOLDERS**

Dear Shareholders,

I am pleased to present an overview of our company's performance during the year 2025-26 and outlook for the future.

**Overview of global and Indian state of economy:****Global Economy**

FY 2025–26 saw a major realignment in international trade. Early 2025 US tariff moves triggered reciprocal measures from key partners, accelerating supply-chain fragmentation and raising policy uncertainty. Multilateral bodies, including the IMF, trimmed growth forecasts in response. Geopolitical tensions further disrupted trade flows. At the same time, AI-led capital spending surged, altering technology investment patterns and productivity prospects, while institutional capital continued to flow into clean-energy transitions.

**Indian Economy**

Despite global headwinds and tariff shocks, India maintained its position among the world's fastest-growing large economies. Retail inflation, especially food, eased from the previous year, supporting consumer purchasing power. Targeted income-tax relief and GST rationalisation supported demand. Manufacturing remained on a positive path, aided by Production-Linked Incentives, and policy emphasis on renewables and advanced electronics manufacturing should bolster sustainable, self-reliant growth.

**Company Performance**

The Company has reported a loss of ₹ 2164 lacs for the year, which shows a decline in performance compared to a loss of ₹ 1888 lacs for the previous year. The amount of reported profitability is after considering a negative impact of ₹ 479 lacs on account of deferred tax asset for the year under review, compared to positive amount (credit) of ₹ 1486 lacs in the previous year. The key aspects of the Company's performance are set out below:

**Real Estate Division:** During the year, the Division recorded revenue of ₹ 566 lacs compared to ₹ 526 lacs in the previous year. The Division has two projects on hand — “Swan Lake”, a plotted development project, and “The Sovereign”, a premium high-rise residential apartment project. Construction and development activities across both projects are progressing well.

**Investment Division:** The performance of the Division, on a year-on-year comparison, was impacted by volatile and subdued stock market conditions prevailing during the year. However, the Division continued to outperform the benchmark indices in terms of TWRR. During the year, the Division recorded a TWRR of 5.66% against the benchmark return of (-3.12%). Further, from the date of transition to the Portfolio Management Services (PMS) structure in March 2025, the portfolio delivered a TWRR of 17.68% as compared to 3.67% for the benchmark. TWRR is a SEBI-prescribed performance measurement metric for PMS investments. The Company's investment portfolio is managed by its wholly owned subsidiary, Ashima Capital Management Limited (ACML), under its Portfolio Management Services business. ACML is registered with SEBI as a Portfolio Manager.

**Outlook:**

The Company remains optimistic about the growth prospects of its Real Estate business, supported by expanding opportunities across diverse segments in Ahmedabad. The Company believes the sector is well-positioned to sustain its positive momentum in the foreseeable future. In respect of the Investment Division, the Portfolio Management Services (PMS) in which the Company has invested are managed by its wholly owned subsidiary. The underlying investment philosophy is based on a proven and disciplined strategy of value investment, with a sound track record of performance, which is expected to continue generating stable long-term performance.

**Conclusion**

As I reflect on the road we have travelled together, I would like to thank our shareholders for their enduring trust and support. Looking ahead, the Company remains firmly resolved to harness its capabilities, rise above the hurdles that growth demands, and deliver lasting value to all its stakeholders.

The amount of reported profitability is after considering a negative impact of ₹ 479 lacs on account of deferred tax for the year under review, compared to positive amount (credit) of ₹ 1486 lacs in the previous year.

The operational performance of the company was subdued during the year on account of lower profitability of both Real Estate division and Investment Division. As regards Real Estate business, there was a decline in performance compared to the previous year. Performance of Investment Division has been lower due to overall bearishness in the stock market, as we can see from the movement of the stock market indices, but we have managed to outperform the benchmarks during the year.

**Real Estate Division:**

The Division has two ongoing projects — "Swan Lake", a plotted development project, and "The Sovereign", a premium high-rise residential apartment project. There has been consistent progress in project execution in case of both the projects. During the year, the Division recorded revenue of ₹ 566 lacs.

**Investment Division:**

The investment portfolio of the Company is managed by its wholly owned subsidiary, Ashima Capital Management Limited (ACML), as part of its Portfolio Management Services (PMS). ACML is registered with SEBI as a PMS entity.

Performance of the Division was affected due to volatile and sluggish stock market during the year. The Division has reported a profit of ₹ 61 lacs compared to ₹ 389 lacs in the previous year. It is noteworthy that the division has outperformed the benchmark indices in terms of TWRR over time. The performance for the year in terms of TWRR was at 5.66% compared to -3.12% of the benchmark. It was 17.68% from inception (i.e. the date of transition to PMS) till the year-end, compared to 3.67% of the benchmark. ACML follows the philosophy of value investment, with investments being made in equity shares with a long-term perspective.

**Consolidated Financials:**

The consolidated financials of the Company, which include financials of Ashima Capital Management Limited, a wholly owned subsidiary, are presented for the year under review. As per consolidated financials, there is a loss of ₹ 2030 lacs compared to loss of ₹ 2164 lacs on standalone basis.

A detailed discussion on performance and outlook appears as part of Management Discussion and Analysis Report attached to this report.

The Company does not have any Joint Venture (JV) or Associate Company as on March 31, 2026.

During the financial year under review, there was no change in the authorized and paid-up share capital of your Company. The authorized share capital and paid up share capital of your Company is ₹ 2,12,16,00,780.

Your Directors state that no disclosure or reporting is required in respect of the following items, as there were no transactions on these items during the financial year under review:

- a. Issue of equity shares with differential rights as to dividend, voting or otherwise.
- b. Issue of shares (including sweat equity shares) to employees of the Company under any scheme including Employee Stock Option Scheme.

**40. NON-CONVERTIBLE DEBENTURES**

1. During the year under review, the Company raised funds aggregating to ₹ 12000 Lacs through issuance of Unlisted, Secured, Unrated, Redeemable, Rupee Denominated Non-Convertible Debentures (NCDs) on a private placement basis, which is within the overall approved limit of ₹ 13000 Lacs. The Company allotted 5,000 NCDs of ₹ 1,00,000 each aggregating to ₹ 5000 Lacs on July 21, 2025 and further allotted 7,000 NCDs of ₹ 1,00,000 each aggregating to ₹ 7000 Lacs on July 31, 2025.
2. The Company had issued 5,000 fully paid-up, unlisted, secured, unrated, redeemable, rupee-denominated Non-Convertible Debentures of ₹ 1,00,000 each aggregating to ₹ 5000 Lacs to Subahu Enterprises LLP. During the year, the Company redeemed the said NCDs in two tranches pursuant to exercise of call option available to the Company under the Debenture Trust Deed 4,500 NCDs were redeemed on July 14, 2025 and the balance 500 NCDs were redeemed on September 2, 2025 along with applicable interest. Consequently, all the NCDs issued by the Company to Subahu Enterprises LLP stood fully redeemed.
3. The Company had also issued fully paid-up, unlisted, secured, unrated, redeemable, rupee-denominated Non-Convertible Debentures aggregating to ₹ 5500 Lacs to Crystal Quinone Pvt. Ltd. and Sharanam Metrolinks LLP. During the year, the Company exercised its call option for partial early redemption of the said NCDs in accordance with the terms of the Debenture Trust Deeds. An amount aggregating to ₹ 2425 Lacs was redeemed in September 2025, followed by further partial redemption aggregating to ₹ 400 Lacs in March 2026, by way of reduction in the outstanding principal value of the NCDs. Consequently, NCDs aggregating to ₹ 2675 Lacs remained outstanding as on March 31, 2026 and continue under their original terms and conditions.

As on March 31, 2026, the Audit Committee comprised of 3 (three) Directors viz., Mr. Nilesh Mehta - Chairman, Mr. Sanjay Majmudar, Member and Mrs. Koushlya Melwani, Members of the committee. The constitution of audit committee meets the requirements of Section 177 of the Companies Act, 2013 and Regulation 18 of SEBI Listing Regulations.

• **Brief description of terms of reference of Audit Committee:**

The major terms of reference of the Audit Committee include oversight of financial reporting process, review of quarterly /annual financial statements, ensuring compliance with the applicable regulatory guidelines, review of functioning of whistle blower (vigil) mechanism, review and approval of related party transactions including criteria for granting omnibus approval, review of internal audit reports, evaluation of internal financial controls and risk management systems, scrutiny of inter corporate loans and investments, recommending appointment/re-appointment and remuneration of auditors to the Board of Directors, review of internal control system and internal audit function and also the adequacy and performance of auditors.

**4. Nomination and Remuneration Committee (NRC):**

The Board of Directors of the Company has constituted a Nomination and Remuneration committee in the year 2003. The composition of committee has been changed as and when required and lastly it has been re-constituted by the Board of Directors in their meeting held on August 8, 2024.

The powers, roles and terms of reference of the Nomination and Remuneration Committee covers the area as contemplated under Regulation 19 of SEBI Listing Regulations and Section 178 of the Companies Act, 2013, besides other terms as may be referred by the Board of Directors. The role of Nomination and Remuneration Committee includes:

- a) Formulation of the criteria for determining qualification, positive attributes and independence of a director and recommend to the board of directors a policy relating to the remuneration of the directors, key managerial personnel and other employees;
- b) For every appointment of an independent director, the Nomination and Remuneration Committee shall evaluate the balance of skills, knowledge and experience on the Board and on the basis of such evaluation, prepare a description of the role and capabilities required of an independent director. The person recommended to the Board for appointment as an independent director shall have the capabilities identified in such description. For the purpose of identifying suitable candidates, the Committee may:
  - a. use the services of external agencies, if required;
  - b. consider candidates from a wide range of backgrounds, having due regard to diversity; and
  - c. consider the time commitments of the candidates.
- c) formulation of criteria for evaluation of performance of independent directors and the board of directors;



- d) devising a policy on diversity of board of directors;
- e) identifying persons who are qualified to become directors and who may be appointed in senior management in accordance with the criteria laid down, and recommend to the board of directors their appointment and removal.
- f) whether to extend or continue the term of appointment of the independent director, on the basis of the report of performance evaluation of independent directors.
- g) Recommend to the Board, remuneration, in whatever form, payable to senior management.

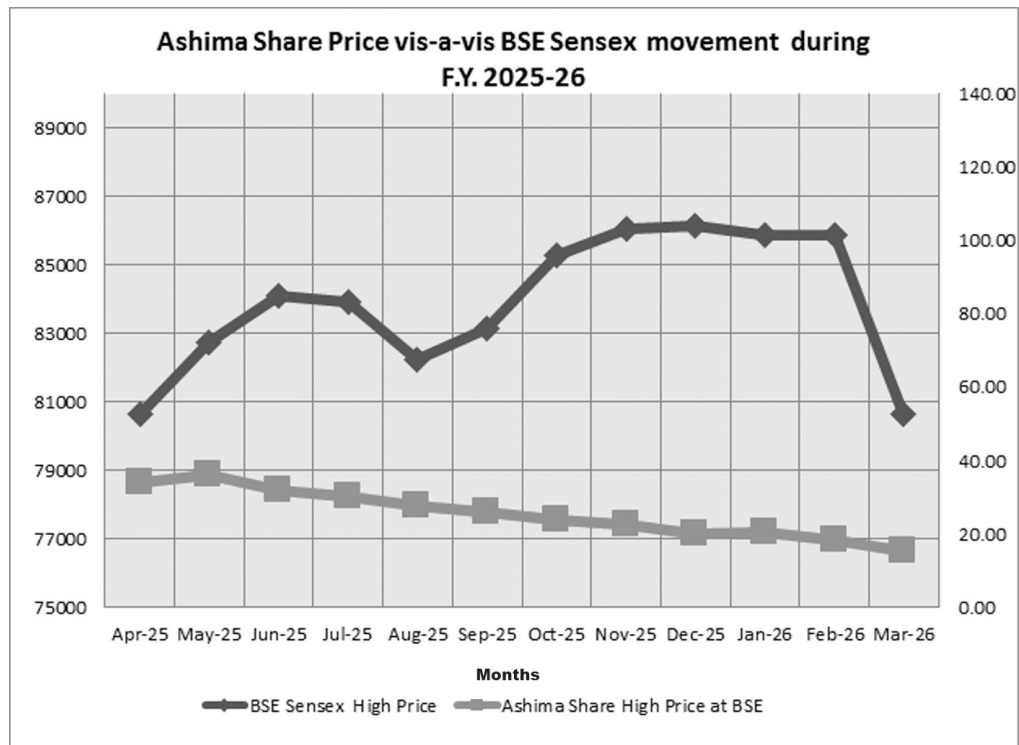

## **ANNEXURE-5**

### **MANAGEMENT DISCUSSION AND ANALYSIS REPORT**

#### **Economic Overview and Outlook**

##### **Global Economy**

FY 2025–26 was marked by a sharp reconfiguration of global trade. The United States introduced sweeping tariff measures in early 2025, prompting retaliatory responses from major trading partners and accelerating the fragmentation of established supply chains. Multilateral institutions, including the IMF, revised global growth forecasts downward, reflecting heightened policy uncertainty. Further, geopolitical conflicts have played a disruptive role almost across the world, disturbing global trades. Against this backdrop, AI-driven capital expenditure surged globally, reshaping technology investment patterns and productivity outlooks, while clean energy transitions attracted sustained institutional capital.

##### **Indian Economy**

India has navigated well in the times of global stress and more importantly, adverse factors like the US tariffs. It has managed to continue its position as one of the world's most dynamic and largest growing major economies. Retail inflation — particularly food prices — receded from elevated levels of the prior year, supporting purchasing power. Meaningful personal income tax relief and rationalisation of GST rates provided impetus to consumption. Manufacturing output stayed positive, bolstered by Production-Linked Incentive policy. Continued policy focus on several key sectors including renewable energy sector and manufacturing of complex electronic chips will help the country in its march towards sustainable growth and self-reliance.

##### **Company's Performance**

The operational performance of the company was subdued during the year on account of lower profitability of both Real Estate Division and Investment Division.

##### **Segment-wise Analysis and Review**

With the closure of cotton textile operations during the previous year, its performance is presented as "discontinued operations" as per requirements of IND AS 105. Performance analysis for Real Estate and Investment segments during the year is presented as follows:

##### **Real Estate Division:**

The Division is currently advancing two active projects — "Swan Lake", a plotted development project, and "The Sovereign", a premium high-rise residential apartment project. Both projects continue to see steady momentum in their construction and development phases. During the year, the Division recorded revenue of ₹ 566 lacs.

##### **Investment Division:**

The investment portfolio of the Company is managed by its wholly owned subsidiary, Ashima Capital Management Limited (ACML), as part of its Portfolio Management Services (PMS). ACML is registered with SEBI as a PMS entity.

Performance of the Division was affected due to volatile and sluggish stock market during the year. The Division has reported a profit of ₹ 61 lacs compared to ₹ 389 lacs in the previous year. The division has outperformed the benchmark indices in terms of TWRR over time. The performance for the year in terms of TWRR was at 5.66% compared to -3.12% of the benchmark and it was 17.68% from the date of transition to PMS, compared to 3.67% of the benchmark.

ACML follows the philosophy of value investment, with investments being made in equity shares with a long-term perspective. As per accounting norms, periodic performance is reported based on realised profits and incomes as well as market value of shares held at the end of the period.

#### **FINANCIAL RESULTS AND OUTLOOK:**

##### **Financial performance:**

The Company has reported a loss of ₹ 2164 lacs for the year, which shows a decline in performance compared to a loss of ₹ 1888 lacs for the previous year. The amount of reported profitability is after considering a negative impact of ₹ 479 lacs on account of deferred tax asset for the year under review, compared to positive amount (credit) of ₹ 1486 lacs in the previous year.

Operational performance of Real Estate business declined compared to the previous year. Salary cost of



the Division went up, as it strengthened the team to keep pace with faster execution of both the projects. Also, its interest income on deployment of surplus funds was on the lower side, since it deployed funds in projects during the year. As regards Investment Division, its performance was affected by volatile and sluggish stock market.

Significant changes in financial ratios and explanations thereon are appearing at note no. 48 to the Financial Statements.

**Outlook:**

The Company expects its Real Estate business to witness sustained growth in the coming years, supported by significant opportunities across various market segments in Ahmedabad. The city has demonstrated consistent expansion in the real estate sector over the past several years, and the Company believes that this positive growth trajectory is likely to continue. As regards its Investment Division, the PMS in which the Company has invested is managed by its wholly owned subsidiary. There is a time tested strategy in place, which is likely to continue performing well in the time to come.

**Opportunities:**

The Real Estate sector continues to offer sound long term growth opportunities for the Company in the years to come. With respect to its Investment Division, the Company believes that the expanding economy and strong performance of corporates are expected to continue creating attractive investment opportunities with the potential to generate healthy returns over the long term.

**Threats:**

The Real Estate business does not face any major threats, considering the region and sectors that the Company operates in. However, rising land and construction costs may exert upward pressure on overall property costs, which could adversely impact demand of properties as well as profit margins.

**Risks and Concerns:**

The Company has established a robust and dynamic risk management framework that enables timely identification, assessment, and monitoring of potential risks. This structured approach assists the management in implementing appropriate and effective mitigation measures in a proactive and timely manner.

**Internal control systems and their adequacy:**

Over the years, the Company has established sound internal control systems commensurate with the size and nature of its business activities, ensuring that the interests of the Company are adequately safeguarded. The Board of Directors and Audit Committee are responsible for ensuring that the internal control systems laid down by the Company are appropriate, compliant with regulatory requirements and are operating effectively, for which they review the same at regular intervals.

**Human Resources and Industrial Relations:**

Human resources constitute the cornerstone of the Company's long-term success and sustainable growth. Recognising employees as its valuable asset, the Company remains committed to fostering a safe, secure, and conducive work environment that promotes professional development, employee well-being, and operational excellence. This continued focus enables the Company to attract, nurture, and retain high-quality talent essential for achieving its strategic objectives and enhancing overall organizational performance. As of March 31, 2026, the Company had 52 permanent employees on its roll.

**Notes to the Financial Statements**

---

**Note: 1 Corporate Information:**

Ashima Limited is engaged in Real Estate business and Investment activity.

The Company has two ongoing Real Estate projects on hand. The first project of the Company, "Swan Lake" is a weekend homes project on the western outskirts of Ahmedabad city, spanning on about 90 acres. It features a lavish, fully equipped clubhouse and thoughtfully designed amenities for recreation and relaxation, all nestled in meticulously landscaped greenery.

The other project is 'The Sovereign', a luxurious residential project with 102 exclusive residences in a 430 ft. tall tower having 37 floors. It offers meticulously designed amenities and facilities tailored for residents' comfort, situated in a high-end neighbourhood in west Ahmedabad.

The Company has a wholly owned subsidiary, named Ashima Capital Management Limited ("ACML"), which is engaged in portfolio management activity as a SEBI-Registered Portfolio Manager under SEBI (PMS) Regulations. ACML is managing portfolios of various entities, including that of Ashima Limited, with assets under management of ₹ 302 Crs as on the Balance Sheet date.

The company is a public company domiciled in India and is incorporated under the provisions of the Companies Act, 1956 (now Companies Act, 2013) ("the Act"). Its shares are listed on the Bombay Stock Exchange (BSE Limited) and the National Stock Exchange (National Stock Exchange of India Limited) in India. The registered office of the company is located at 1st Floor, "Aditya", Near Khadayata Colony, Ellisbridge, Ahmedabad - 380006.

The financial statements for the year ended March 31, 2026 were authorised for issue in accordance with a resolution of the directors passed at their meeting held on May 23, 2026.

**Note: 2 Material Accounting Policies:**

The following note provides list of the material accounting policies adopted in the preparation of these financial statements.

These policies have been consistently applied to all the years presented unless otherwise stated.

**1 Basis of preparation:**

- A** The financial statements have been prepared in accordance with Indian Accounting Standards (Ind AS) notified under the Companies (Indian Accounting Standards) Rules, 2015, as amended and other relevant provisions of the Companies Act, 2013.
- B** The financial statements have been prepared on historical cost basis, except for the following assets and liabilities which have been measured at fair value or revalued amount:
  - i** Derivative financial instruments
  - ii** Certain financial assets and liabilities measured at fair value [refer accounting policy regarding financial instruments]
  - iii** Defined benefit plans
  - iv** Certain items of Property, Plant and Equipment
- C** The amounts mentioned in the financial statements are rounded off to the nearest Lac. Figures less than J 50,000/- appear as zero ("0"). As the quarterly and yearly figures are taken from the sources and rounded to the nearest digits, the figures already reported for all the quarters during the yearly might not always add up to the yearly figures reported in this statement.

**2 Use of Estimates:**

The preparation of the financial statements in conformity with Ind AS requires management to make



estimates, judgments and assumptions. These estimates, judgments and assumptions affect the application of accounting policies and the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities at the date of the financial statements and reported amounts of income and expenses during the period. Application of accounting policies that require critical accounting estimates involving complex and subjective judgments are provided below.

Accounting estimates could change from period to period. Actual results could differ from those estimates. Appropriate changes in estimates are made as management becomes aware of changes in circumstances surrounding the estimates. Changes in estimates are reflected in the financial statements in the period in which changes are made and, if material, their effects are disclosed in the notes to the financial statements.

**Critical estimates and judgments:**

- a** Determination of revenue under the satisfaction of performance obligation necessarily involves making estimates, some of which are of a technical nature, concerning, where relevant, the timing of satisfaction of performance obligation, costs to completion for the project or activity and the foreseeable losses to completion. Estimates of project income, as well as project costs, are reviewed periodically. The Company recognises revenue when the Company satisfies its performance obligation.
- b** **Income Taxes:**  
Significant judgments are involved in determining the provision for income taxes, including amount expected to be paid/ recovered for uncertain tax positions, and in estimation of deferred tax asset or liability.
- c** **Property, plant and equipment:**  
Property, plant and equipment represent a significant proportion of the asset base of the Company. The charge in respect of periodic depreciation is derived after determining an estimate of an asset's expected useful life and the expected residual value at the end of its life. Management reviews the residual values, useful lives and methods of depreciation of property, plant and equipment at reasonable intervals and any revision to these is recognised prospectively in current and future periods. The useful lives are based on historical experience with similar assets as well as anticipation of future events, which may affect their life, such as changes in technology.  
  
Significant judgments are involved in determining the estimated future cash flows and/or net realisable value from the property, plant and equipment to determine its value in use to assess whether there is any impairment in its carrying amount as reflected in the financials.
- d** **Employee Benefits:**  
Significant judgments are involved in making estimates about the life expectancy, discounting rate, salary increase, etc. which significantly affect the working of the present value of future liabilities on account of employee benefits by way of defined benefit plans.
- e** Significant judgment is involved in making estimate about the fair value of the non-convertible debentures issued by the company on which no interest is payable and which are to be redeemed at a premium which is calculated based on project IRR as per terms of the debentures.
- f** **Product quality claims:**  
Significant judgments are involved in determining estimated value of likely product quality claims.
- g** **Insurance claims:**  
Significant judgments are involved in determining estimated value likely to be received

in respect of insurance claims lodged in respect of loss/damage to properties/stock of the company.

**3 Non-Current assets (or disposal groups) held for sale:**

Non-Current assets and disposal groups are classified as held for sale if their carrying amount will be recovered principally through a sale transaction rather than through continuing use. This condition is regarded as met only when the asset (or disposal group) is available for immediate sale in its present condition subject only to terms that are usual and customary for sales of such asset (or disposal group) and its sale is highly probable. Management must be committed to the sale, which should be expected to qualify for recognition as a completed sale within one year from the date of classification.

Non-Current assets (and disposal groups) classified as held for sale are measured at the lower of their carrying amount and fair value less costs to sell except for those assets that are specifically exempt under relevant Ind AS. Once the assets are classified as "Held for sale", those are not subjected to depreciation till disposal.

An impairment loss is recognised for any initial or subsequent write-down of the asset (or disposal group) to fair value less costs to sell. A gain is recognised for any subsequent increases in fair value less costs to sell of an asset (or disposal group), but not in excess of any cumulative impairment loss previously recognised.

A gain or loss not previously recognised by the date of the sale of the non-current asset (or disposal group) is recognised at the date of derecognition.

Non-current assets classified as held for sale and the assets of a disposal group classified as held for sale are presented separately from the other assets in the balance sheet.

**4 Discontinued operation:**

A discontinued operation is a component of an entity that either has been disposed of, or is classified as held for sale and that represents a separate line of business or geographical area of operations, is part of single coordinated plan to dispose of such a line of business or area of operations, or is a subsidiary acquired exclusively with a view to resale. The results of discontinued operations are presented separately in the statement of profit and loss.

**5 Foreign Currency Transactions:**

- A** The Company's financial statements are presented in Indian Rupees (₹), which is the functional and presentation currency.
- B** The transactions in foreign currencies are translated into functional currency at the rates of exchange prevailing on the dates of transactions.
- C** Foreign Exchange gains and losses resulting from settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at the year-end exchange rates are recognised in the Statement of Profit and Loss.
- D** Foreign exchange differences regarded as an adjustment to borrowing costs are presented in the Statement of Profit and Loss as part of finance costs. All the other foreign exchange gains and losses are presented in the Statement of Profit and Loss on a net basis.

**6 Revenue Recognition:**

- A** Revenue is recognised to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be reliably measured, regardless of when the payment is being made. Revenue is measured at the fair value of the consideration received or receivable, taking into account contractually defined terms of payment and excluding taxes or duties collected on behalf of the government and is shown net of returns, trade allowances, rebates, volume discounts and value added taxes. The Company



derives revenues primarily from sale of manufactured goods, traded goods and related services. The Company is also engaged in real estate property development. Revenue is recognized on satisfaction of performance obligation upon transfer of control of promised products or services to customers in an amount that reflects the consideration the Company expects to receive in exchange for those products or services.

- B** In determining the transaction price, the Company considers the effects of variable consideration and the existence of significant financing components, if any.
- C** GST is not received by the Company on its own account, but is tax collected on value added to the goods/ services by the Company on behalf of the government. Accordingly, it is excluded from revenue.
- D** For revenue to be recognised, the following specific recognition criteria for each types of revenue must be satisfied:

- a Sale of Goods:**

- Revenue from the sale of goods is recognised when the control of the goods has passed to the buyer, usually on delivery of the goods. Revenue from the sale of goods is measured at the fair value of the consideration received or receivable, net of returns, trade allowances, rebates, volume discounts and GST.

- The goods are often sold with volume discounts/pricing incentives and customers have a right to return defective products. Revenue from sales is based on the price in the sales contracts, net of discounts. Historical experience is used to estimate and provide for customer claims. No element of financing is deemed present, as the sales are made with the normal credit terms as per prevalent trade practice and credit policy followed by the Company.

- b Real Estate Transactions:**

- The Company satisfies a performance obligation and recognises revenue over time, if one of the following criteria is met:

- 1. The customer simultaneously receives and consumes the benefits provided by the Company's performance as the Company performs.
    2. The Company's performance creates or enhances an asset that the customer controls as the asset is created or enhanced; or
    3. The Company's performance does not create an asset with an alternative use to the Company and the entity has an enforceable right to payment for performance completed to date.

- For performance obligations where none of the above conditions are met, revenue is recognised at the point in time at which the performance obligation is satisfied.

- Revenue in excess of invoicing are classified as contract asset, while invoicing in excess of revenues are classified as contract liabilities.

- c Service Income:**

- Service income is recognised as per the terms of contracts with the customers when the related services are performed and are net of GST, wherever applicable.

- d Interest Income:**

- For all debt instruments measured at amortized cost, interest income is recorded using the effective interest rate (EIR). EIR is the rate that exactly discounts the estimated future cash payments or receipts over the expected life of the financial instrument or a shorter period, where appropriate, to the gross carrying amount of the financial asset or to the amortized cost of a financial liability. When calculating the effective interest rate, the Company estimates the expected cash flows by

considering all the contractual terms of the financial instrument, but does not consider the expected credit losses.

- e Claims receivable on account of Insurance are accounted for to the extent the Company is reasonably certain of their ultimate collection.

- f **Dividend Income:**

Dividend Income is recognized when the right to receive the same is established.

- g **Other Income:**

Other income is recognised when no significant uncertainty as to its determination or realisation exists.

## **7 Taxes on Income:**

Tax expenses comprise of current and deferred tax.

### **A Current Tax:**

- a Current tax is measured at the amount expected to be paid on the basis of reliefs and deductions available in accordance with the provisions of the Income Tax Act, 1961. The tax rates and tax laws used to compute the amount are those that are enacted or substantively enacted, at the reporting date.
- b Current tax items are recognised in correlation to the underlying transaction either in Statement of Profit and Loss, Other Comprehensive Income (OCI) or directly in equity.
- c Management periodically evaluates positions taken in the tax returns with respect to situations in which applicable tax regulations are subject to interpretation and establishes provisions where appropriate.

### **B Deferred Tax:**

- a Deferred tax is provided using the liability method on temporary differences between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes at the reporting date.
  - b Deferred tax liabilities are recognised for all taxable temporary differences.
  - c Deferred tax assets are recognised for all deductible temporary differences and carry forward of unused tax losses.  
  
Deferred tax assets are recognised to the extent it is probable that taxable profit will be available against which the deductible temporary differences and carry forward of unused tax losses can be utilized.
  - d The carrying amount of deferred tax assets is reviewed at each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilized. Unrecognised deferred tax assets are re-assessed at each reporting date and are recognised to the extent that it has become probable that future taxable profits will allow the deferred tax asset to be recovered.
  - e Deferred tax assets and liabilities are measured at the tax rates (and tax laws) that have been enacted or substantively enacted at the reporting date and are expected to apply in the year when the asset is realised or the liability is settled.
  - f Deferred tax items are recognised in correlation to the underlying transaction either in Statement of Profit and Loss, Other Comprehensive Income (OCI) or directly in equity.
  - g Deferred tax assets and deferred tax liabilities are offset if a legally enforceable right exists to set off current tax assets against current tax liabilities.
-

**8 Property, Plant and Equipment:**

- A** Property, Plant, and Equipment including leasehold land existing as on January 1, 2005 have been carried at revalued figures and subsequent additions thereto are accounted for on actual/historical cost basis. Cost includes related expenditure and pre-operative and project expenses for the period upto completion of construction / upto date of assets being ready for its intended use, if recognition criteria are met and the present value of the expected cost for the decommissioning of an asset after its use is included in the cost of the respective asset if the recognition criteria for a provision are met. Cost is reduced by accumulated depreciation and impairment and amount representing assets discarded or held for disposal. On transition to Ind AS as on April 1, 2016, the Company has elected to measure its Property, Plant and Equipment at carrying value as per previous GAAP. As per the requirement of paragraph 11 of Ind AS 101, outstanding amount in the revaluation reserve was transferred to retained earning account upon transition to Ind AS, since the Company is no longer applying the revaluation model of Ind AS 16 upon transition and has elected to apply the cost model approach.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. All other repairs and maintenance are charged to the Statement of Profit and Loss during the reporting period in which they are incurred.

- B** Where components of an asset are significant in value in relation to the total value of the asset as a whole, and they have substantially different economic lives as compared to principal item of the asset, they are recognised separately as independent items and are depreciated over their estimated economic useful lives.
- C** Depreciation on tangible assets is provided on "straight line method". Useful life of tangible assets except buildings as per following details are different from that prescribed in Schedule II of the Act, which have been arrived at based on technical evaluation. The management believes that these estimated useful lives are realistic and reflect fair approximation of the period over which the assets are likely to be used. However, management reviews the residual values, useful lives and methods of depreciation of property, plant and equipment at reasonable intervals. Any revision to these is recognized prospectively in current and future periods.

- D** Depreciation on impaired assets is calculated on its reduced value, if any, on a systematic basis over its remaining useful life.
- E** Depreciation on additions/ disposals of the property, plant & equipment during the year is provided on pro-rata basis according to the period during which assets are used.
- F** Capital work in progress is stated at cost less accumulated impairment loss, if any. All other repair and maintenance costs are recognised in Statement of Profit or Loss as

incurred, unless they meet the recognition criteria for capitalisation under property, plant and equipment.

- G** An item of property, plant and equipment and any significant part thereof initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on de-recognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the Statement of Profit and Loss when the asset is derecognised.

## **9 Leases**

- A** The Company has adopted Ind AS 116 “Leases” using the modified retrospective approach, initially applying this standard from April 1, 2019. Accordingly, the information presented for previous year ended March 31, 2019, is not restated and reported as per Ind AS 17.

- B** The Company evaluates if an arrangement qualifies to be a lease as per the requirements of Ind AS 116 and this may require significant judgment. The Company also uses significant judgment in assessing the lease term (including anticipated renewals) and the applicable discount rate.

The Company determines the lease term as the non-cancellable period of a lease, together with both periods covered by an option to extend or terminate the lease if the Company is reasonably certain based on relevant facts and circumstances that the option to extend or terminate will be exercised. If there is a change in facts and circumstances, the expected lease term is revised accordingly.

The discount rate is generally based on the interest rate specific to the lease being evaluated or if that cannot be easily determined the incremental borrowing rate for similar term is used.

The Company has elected not to recognise right-of-use assets and lease liabilities for short-term leases that have a lease term of 12 months or less and leases of low-value assets. The Company recognises the lease payments associated with these leases as an expense on a straight-line basis over the lease term.

The lease liability is initially measured at the present value of the lease payments that are not paid at the commencement date, discounted using the Company's incremental borrowing rate. It is remeasured when there is a change in future lease payments arising from a change in an index or rate, or a change in the estimate of the amount expected to be payable under a residual value guarantee, or a change in the assessment of whether it will exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the amount of the right-of-use asset, or is recorded in the Statement of Profit and Loss if the carrying amount of the right-of-use asset has been reduced to zero. The right of-use asset is measured by applying cost model i.e. right-of-use asset at cost less accumulated depreciation /impairment losses (Refer note no. 13 for impairment).

### **C The Company as a lessee:**

The Company recognises a right-of-use asset and a lease liability at the lease commencement date. The right-of-use asset is initially measured at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or before the commencement date, plus any initial direct costs incurred and restoration cost, less any lease incentives received.

The right-to-use assets are subsequently depreciated over the shorter of the asset's useful life and the lease term on a straight-line basis. In addition, the right-to-use asset is reduced by impairment losses, if any.



The lease liability is initially measured at amortised cost at the present value of the future lease payments. When a lease liability is remeasured, the corresponding adjustment of the lease liability is made to the carrying amount of the right-of-use asset, or is recorded in the Statement of Profit and Loss, if the carrying amount of the right-to-use asset has been reduced to zero.

The right to use appears as part of fixed assets and the lease liability appears as non current and current liability in the Balance Sheet.

Rent concessions are accounted for as per provisions of the revised Ind-AS 116 "Leases".

**10 Intangible Assets:**

- A** Intangible assets acquired separately are measured on initial recognition at cost. Following initial recognition, intangible assets are carried at cost less any accumulated amortisation and accumulated impairment losses.
- B** Capitalised cost incurred towards purchase/ development of software is amortized using straight line method over its useful life of six years as estimated by the management at the time of capitalisation.
- C** An item of intangible asset initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on de-recognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the Statement of Profit and Loss when the asset is derecognised.

**11 Borrowing Costs:**

- A** Borrowing costs consist of interest and other borrowing costs that are incurred in connection with the borrowing of funds. Other borrowing costs include ancillary charges at the time of acquisition of a financial liability, which is recognised as per EIR method. Borrowing costs also include exchange differences to the extent regarded as an adjustment to the borrowing costs.
- B** Borrowing costs that are directly attributable to the acquisition / construction of a qualifying asset are capitalised as part of the cost of such assets, up to the date the assets are ready for their intended use.
- C** For capitalization of eligible borrowing costs which are not specifically attributable to the acquisition, construction or production of a particular qualifying asset, a weighted average capitalization rate is applied for all the eligible assets.

The weighted average rate is considered of the borrowing costs applicable to the outstanding borrowings of the company during the period, other than borrowings made specifically for the purpose of obtaining a qualifying asset.

**12 Impairment of Assets:**

The carrying amounts of Property, Plant and Equipment and intangible assets are reviewed at each balance sheet date if there is any indication of impairment based on internal/external factors. An impairment loss is recognized wherever the carrying amount of an asset exceeds its recoverable amount. The recoverable amount is the greater of the asset's net selling price and value in use. In assessing value in use, the Company measures it on the basis of discounted estimated cash flows for the remaining years (remaining useful life). Assessment is also done at each Balance Sheet date as to whether there is any indication that an impairment loss recognized for an asset in prior accounting periods may no longer exist or may have decreased. After impairment, depreciation is provided on the revised carrying amount of the asset over its remaining useful life.

**13 Inventories:**

- A** Inventories are valued at the lower of cost and net realisable value ("NRV"). NRV

represents the estimated selling price in the ordinary course of business, less the estimated costs of completion and the estimated costs necessary to make the sale.

**B** The cost of inventories comprises direct expenditure related to real estate activities and other expenditures to the extent that such expenditures are directly attributable to bringing the asset to its working condition for its intended use.

**C** Work-in-progress represents costs incurred in respect of unsold areas of real estate projects or costs incurred on projects for which revenue recognition criteria have not yet been met.

**14 Cash and Cash Equivalents:**

Cash and Cash equivalents for the purpose of Cash Flow Statement comprise cash and cheques in hand, bank balances, demand deposits with banks where the original maturity is three months or less and other short term highly liquid investments.

**15 Provisions, Contingent Liabilities, Contingent Assets and Commitments:**

**A** Provisions are recognised when the Company has a present obligation as a result of past events and it is probable that the outflow of resources will be required to settle the obligation and in respect of which reliable estimates can be made.

When the company expects some or all of a provision to be reimbursed, for example, under an insurance contract, the reimbursement is recognised as a separate asset, but only when the reimbursement is virtually certain. A disclosure for contingent liability is made when there is a possible obligation, that may, but probably will not require an outflow of resources. When there is a possible obligation or a present obligation in respect of which the likelihood of outflow of resources is remote, no provision/ disclosure is made. Contingent Liabilities are not recognised but are disclosed separately in the financial statements. Commitments include the amount of purchase order (net of advances) issued to parties for completion of assets. Provisions, contingencies and commitments are reviewed at each balance sheet date and adjusted to reflect the correct management estimates.

**B** If the effect of the time value of money is material, provisions are discounted using a current pre-tax rate that reflects, when appropriate, the risks specific to the liability.

**16 Provision for Product Quality Claims:**

Provisions for claims raised by customers for products sold by the company are made on management estimates based on claim history and other relevant factors. The initial estimate of the claim is revised at each reporting period.

**17 Employee Benefits:**

**A Short term obligations:**

Liabilities for wages and salaries, including leave encashments that are expected to be settled wholly within 12 months after the end of the period in which the employees render the related service are recognised in respect of employees' services up to the end of the reporting period and are measured by the amounts expected to be paid when the liabilities are settled. The liabilities are presented as current employee benefit obligations in the balance sheet.

**B Long term employee benefits obligations:**

**a Defined Benefit Plans:**

**i Gratuity:**

Liability on account of gratuity is provided for on the basis of actuarial valuation carried out by an independent actuary as at the balance sheet

date. The contribution towards gratuity liability is funded to an approved gratuity fund and the funds are managed by insurance companies. The liability or asset recognised in the balance sheet in respect of defined benefit gratuity plan is the present value of the defined benefit plan obligation at the end of the reporting period less the fair value of the plan assets. The liability with regard to the gratuity Plan is determined by actuarial valuation, performed by an independent actuary, at each balance sheet date using the projected unit credit method. The present value of the defined benefit obligation denominated in ₹ is determined by discounting the estimated future cash outflows by reference to the market yields at the reporting period on government bonds that have terms approximating to the terms of the related obligation.

The net interest cost is calculated by applying the discounting rate to the net balance of the defined benefit obligation and the fair value of plan assets. Such costs are included in employee benefit expenses in the Statement of Profit and Loss. Re-measurements gains or losses arising from experience adjustments and changes in actuarial assumptions are recognised immediately in the period in which they occur directly in "other comprehensive income" and are included in retained earnings in the statement of changes in equity and in the balance sheet.

Re-measurements gains or losses recognized in the other comprehensive income are not reclassified to profit or loss in subsequent periods.

The Company recognises the following changes in the net defined benefit obligation as an expense in the Statement of Profit and Loss:

- i Service costs comprising current service costs and past service costs.
- ii Net interest expense or income.

**b Defined Contribution Plans**

Contribution to provident fund is made to the provident fund administered by the Government and is recognised as employee benefit expenses on accrual basis.

Contribution to National Pension Scheme "NPS", which is also a defined contribution plan, is made to NPS managed by insurance Company and is recognised as employee benefit expenses on accrual basis.

**C Employee Separation Costs:**

The compensation paid to the employees under Voluntary Retirement Scheme is expensed on accrual basis.

**18 Financial Instruments:**

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity.

**A Financial assets:**

**a Initial recognition and measurement:**

All financial assets are recognised initially at fair value plus in the case of financial assets not recorded at fair value through profit or loss, transaction costs that are attributable to the acquisition of the financial asset. Purchases or sales of financial assets that require delivery of assets within a time frame established by regulation or convention in the market place (regular way trades) are recognised on the settlement date, i.e., the date that the Company settles to purchase or sell the asset.

**b Subsequent measurement:**

For purposes of subsequent measurement, financial assets are classified in following categories:

**i Financial Assets at amortized cost:**

A 'financial asset' is measured at the amortized cost if both the following conditions are met:

- The asset is held with an objective of collecting contractual cash flows.
- Contractual terms of the asset give rise on specified dates to cash flows that are "solely payments of principal and interest" (SPPI) on the principal amount outstanding.

After initial measurement, such financial assets are subsequently measured at amortized cost using the effective interest rate (EIR) method. Amortized cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortisation is included in finance income in the Statement of Profit and Loss. The losses arising from impairment are recognised in the Statement of Profit or Loss. This category generally applies to trade and other receivables.

**ii Financial Assets at fair value through other comprehensive income (FVTOCI):**

A 'financial asset' is classified as at the FVTOCI if both of the following criteria are met:

- The asset is held with objective of both - for collecting contractual cash flows and selling the financial assets.
- The asset's contractual cash flows represent SPPI.

Financial Assets included within the FVTOCI category are measured initially as well as at each reporting date at fair value. Fair value movements are recognized in the OCI. However, the Company recognizes interest income, impairment losses and reversals and foreign exchange gain or loss in the Statement of Profit and Loss. On Derecognition of the asset, cumulative gain or loss previously recognised in OCI is reclassified from the equity to Statement of Profit and Loss. Interest earned whilst holding FVTOCI financial asset is reported as interest income using the EIR method.

**iii Financial Assets and derivatives at fair value through profit or loss (FVTPL):**

FVTPL is a residual category for financial assets. Any financial asset, which does not meet the criteria for categorization as at amortized cost or as FVTOCI, is classified as at FVTPL.

Assets included within the FVTPL category are measured at fair value with all changes recognized in the Statement of Profit and Loss.

**c Derecognition:**

A financial asset (or, where applicable, a part of a financial asset) is primarily derecognised when:

- i The right to receive cash flows from the asset has expired, or

- ii The Company has transferred its right to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a 'pass-through' arrangement and either (a) the Company has transferred substantially all the risks and rewards of the asset, or (b) the Company has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Company has transferred its right to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if and to what extent it has retained the risks and rewards of ownership. When it has neither transferred substantially all of the risks and rewards of the asset, nor transferred control of the asset, the Company continues to recognise the transferred asset to the extent of the Company's continuing involvement. In that case, the Company also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Company has retained. When the Company has transferred the risk and rewards of ownership of the financial asset, the same is derecognised.

**d Impairment of financial assets:**

In accordance with Ind AS 109, the Company applies expected credit loss (ECL) model for measurement and recognition of impairment loss on the following financial assets and credit risk exposure:

- a Financial assets that are debt instruments, and are measured at amortized cost.
- b Trade receivables or any contractual right to receive cash or another financial asset.
- c Financial assets that are debt instruments and are measured at FVTOCI.

The Company follows 'simplified approach' for recognition of impairment loss allowance on Point c provided above. The application of simplified approach does not require the Company to track changes in credit risk. Rather, it requires the company to recognise the impairment loss allowance based on lifetime ECLs at each reporting date, right from its initial recognition. For recognition of impairment loss on other financial assets and risk exposure, the Company determines whether there has been a significant increase in the credit risk since initial recognition. If credit risk has not increased significantly, 12-month ECL is used to provide for impairment loss. However, if credit risk has increased significantly, lifetime ECL is used. If, in a subsequent period, credit quality of the instrument improves such that there is no longer a significant increase in credit risk since initial recognition, then the entity reverts to recognising impairment loss allowance based on 12-month ECL.

Lifetime ECL are the expected credit losses resulting from all possible default events over the expected life of a financial instrument. The 12-month ECL is a portion of the lifetime ECL which results from default events that are possible within 12 months after the reporting date.

ECL is the difference between all contractual cash flows that are due to the Company in accordance with the contract and all the cash flows that the entity expects to receive (i.e., all cash shortfalls), discounted at the original EIR. ECL impairment loss allowance (or reversal) recognized during the period is recognized

as income/ expense in the Statement of Profit and Loss. The balance sheet presentation for various financial instruments is described below:

- a** Financial assets measured as at amortized cost and contractual revenue receivables: ECL is presented as an allowance, i.e., as an integral part of the measurement of those assets in the balance sheet, which reduces the net carrying amount. Until the asset meets write-off criteria, the Company does not reduce impairment allowance from the gross carrying amount.
- b** Financial guarantee contracts: ECL is presented as a provision in the balance sheet, i.e. as a liability.

For assessing increase in credit risk and impairment loss, the Company combines financial instruments on the basis of shared credit risk characteristics.

**B Financial liabilities:**

**a Initial recognition and measurement:**

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, payables, or as derivatives designated as hedging instruments in an effective hedge, as appropriate. All financial liabilities are recognised initially at fair value and, in the case of loans, borrowings and payables, net of directly attributable transaction costs.

**b Subsequent measurement:**

Subsequently, all financial liabilities are measured as amortized cost except for financial guarantee contracts, as described below:

**i Loans and borrowings:**

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortized cost using the EIR method. Gains and losses are recognised in Statement of Profit or Loss when the liabilities are derecognised as well as through the EIR amortisation process. Amortized cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortisation is included as finance costs in the Statement of Profit and Loss.

Non interest-bearing non-convertible redeemable Debentures issued by the company, which are to be redeemed at a premium which is calculated based on project IRR as per terms of debentures, are subsequently measured at fair value through profit and loss (FVTPL).

**c Derecognition:**

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognised in the Statement of Profit and Loss.

**C Reclassification of financial assets:**

The Company determines classification of financial assets and liabilities on initial recognition. After initial recognition, no reclassification is made for financial assets which are equity instruments and financial liabilities. For financial assets which are debt instruments, a reclassification is made only if there is a change in the business model

for managing those assets. Changes to the business model are expected to be infrequent. The Company's senior management determines change in the business model as a result of external or internal changes which are significant to the Company's operations. If the Company reclassifies financial assets, it applies the reclassification prospectively from the reclassification date, which is the first day of the immediately next reporting period following the change in business model as per Ind AS 109.

**D Offsetting of financial instruments:**

Financial assets and financial liabilities are offset and the net amount is reported in the balance sheet if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, to realise the assets and settle the liabilities simultaneously.

**19 Derivative Financial Instruments:**

Derivatives are recognised initially at fair value and subsequently at fair value through profit and loss.

**20 Earnings per Share:**

Basic earnings per share are calculated by dividing the net profit or loss (excluding other comprehensive income) for the year attributable to equity shareholders by the weighted average number of equity shares outstanding during the year. The weighted average number of equity shares outstanding during the year is adjusted for events such as bonus issue, bonus element in a right issue, shares split and reverse share splits (consolidation of shares) that have changed the number of equity shares outstanding, without a corresponding change in resources. For the purpose of calculating diluted earnings per share, the net profit or loss (excluding other comprehensive income) for the year attributable to equity shareholders and the weighted average number of shares outstanding during the year are adjusted for the effects of all dilutive potential equity shares.

**Note: 3 - Recent pronouncements:**

The Ministry of Corporate Affairs ("MCA") notifies new standards or amendments to the existing standards under Companies (Indian Accounting Standards) Rules as issued from time to time. During the year ended March 31, 2026, MCA has notified Ind AS 1 - Classification of liabilities as Current or Non-Current, Ind AS 7 - Disclosure of Supplier Finance Arrangements, Ind AS 12 - International Tax Reform (Pillar Two Model Rules) and amendments to Ind AS 21 - Lack of Exchangeability, applicable to the Company w.e.f. April 1, 2026. The Company has reviewed the new pronouncements and based on its evaluation has determined that it does not have any significant impact in its financial statement.

**i. Terms of redemption :**

1% redeemable non-cumulative preference shares of ₹ 100/- each fully paid to be redeemed at par at the end of 20 years from the date of allotment. The Company has an option to redeem the preference shares at par at any time after the end of 12 months from the date of allotment.

**ii. Rights of Preference Shareholders:**

- (i) The company has issued 5,500 (previous year 4,500) Unlisted, Secured, Unrated, Redeemable, Rupee Denominated, Non-Convertible Debentures ("the debentures") of ₹ 1,00,000/- each on private placement basis to part-finance the Company's Project of High-rise Residential Apartments in the name of 'The Sovereign'.

During the year, the Company exercised its Call Option for partial redemption of the said debentures not by cancellation of debentures, but by reduction in paid-up value of the existing NCDs. Accordingly, ₹ 2825 Lacs were redeemed during the financial year. As at March 31, 2026, the aggregate outstanding principal of the said debentures stands at ₹ 2675 Lacs.

**Major Terms of the debentures :**

- 1 Security: The debentures are secured by creation of a first charge on the (a) Project Land (b) FSI thereof and the (c) Project put up/ being put up thereon, in favour of debenture trustee for the benefit of the debenture holders by execution and registration of Deed of Mortgage.
  - 2 No interest is payable on the debentures.
  - 3 Redemption and premium on redemption: On the completion of the project or 7 years from the date of allotment of debentures, whichever is earlier, the Company shall redeem the debentures along with premium (if applicable) to be calculated in a manner that the debenture holders receive premium which is equivalent to an IRR on the Debenture Subscription Amount which is equal to the "Project IRR" as specified in the terms of debentures. The premium on redemption, including partial redemptions, will be computed and paid at the end of the tenure of the NCDs. The Company, at any time after completion of 12 months from the date of allotment, shall have an option to partially or fully redeem the debentures.
  - 4 The debentures have been carried at fair value.
- (ii) The Company had issued 5,000 (previous year 5,000) Unlisted, Secured, Unrated, Redeemable, Rupee Denominated, Non-Convertible Debentures ("the debentures") of ₹ 1,00,000/- each on private placement basis for financing the working capital requirements of the Company. During the year, the Company exercised its Call Option for early redemption of the said debentures. Accordingly, 4,500 NCDs aggregating to ₹ 4500 Lacs were redeemed on July 14, 2025 and the balance 500 NCDs aggregating to ₹ 500 Lacs were redeemed on September 2, 2025. With the aforesaid redemptions, all 5,000 NCDs aggregating to ₹ 5000 Lacs issued to Subahu Enterprises LLP have been fully redeemed during the year and no further NCDs remain outstanding under this series.
- (iii) During the year, the Company has issued 12,000 (previous year Nil) Unlisted, Secured, Unrated, Redeemable, Rupee Denominated, Non-Convertible Debentures ("the debentures") of ₹ 1,00,000/- each on private placement basis, comprising of two tranches - 5,000 NCDs allotted on July 21, 2025 aggregating to ₹ 5000 Lacs and 7,000 NCDs allotted on July 31, 2025 aggregating to ₹ 7000 Lacs aggregating in total to ₹ 12000 Lacs.

**Major Terms of the debentures :**

- 1 Security: The debentures are secured by creation of a first charge on the Non-Agricultural Land in favour of debenture trustee for the benefit of the debenture holder by execution and registration of Deed of Mortgage in compliance with the provisions of applicable laws.
- 2 Interest is payable to debenture holders @ 7.50% per annum, due on March 31, every year.

- 3 Redemption : At the end of 9 (Nine) years from the respective dates of allotment of Debentures with Put Option. The subscriber has a Put Option after the end of 2 (Two) years from the date of allotment, for redemption of Debentures in part or full. In case of any delay in the payment of interest and/or principal amount on the respective due dates, the Issuer shall be liable to pay additional interest at the rate of 1% per annum for the period of delay.
- 4 The debentures have been carried at amortised cost.

**C Unsecured Loan**

The unsecured loans include ₹ 750 Lacs in the suspense account representing amount of a cheque drawn on HDFC Bank given by the company to Bank of Bahrain & Kuwait ("BBK") and amount credited to BBK by RBI clearing house because of the delay by HDFC Bank in returning the cheque to BBK.

The Debt Recovery Tribunal ("DRT"), vide its order dated June 30, 2017 directed BBK (Defendant No. 1) and the Company (Defendant No.2) jointly and severally to pay the suit amount of ₹ 914.23 Lacs with further simple interest @12% per annum on principal amount of ₹ 750 Lacs.

Meanwhile, as part of recovery proceedings filed by HDFC Bank for a decretal amount of ₹ 2070.45 lacs, the Recovery Officer ("RO") passed orders dated March 29, 2019 and April 9, 2019 allowing the application of HDFC Bank for the said decretal amount and inter alia also directed attachment of certain immovable properties of the Company situated at Ahmedabad, Kadi and Mumbai.

The Company filed a writ petition at Hon'ble High Court of Bombay challenging the aforesaid two orders of RO dated March 29, 2019 and April 9, 2019. The Hon'ble Bombay High Court vide an Order dated November 22, 2019 allowed the Company to pursue its said appeal at the Hon'ble DRAT. The Hon'ble High Court also suspended the warrant of attachment against Company's immovable properties and RO's order dated March 29, 2019 till the Company's appeal is decided by the Hon'ble DRAT. The said appeal has been heard and Order dated April 26, 2024 has been passed by the Hon'ble DRAT remanding the matter back to the DRT with directions to consider the question of jurisdiction raised by the Company in the OA together with other issues afresh.

Having taken into consideration the Order passed by the Hon'ble High Court of Bombay and the subsequent Order passed by the Hon'ble DRAT, the Hon'ble Recovery Officer has passed Order on June 19, 2024 for lifting the said attachment on immoveable properties of the Company situated at Ahmedabad, Kadi and Mumbai. At present there is no attachment by DRT on any properties of the Company.

HDFC Bank filed a writ petition at the Hon'ble High Court of Bombay challenging the Order dated April 26, 2024 passed by the Hon'ble DRAT and the Hon'ble High Court of Bombay has by Order dated February 20, 2025 given directions to the Hon'ble DRAT to hear and decide the Appeal filed by the Company without remanding them back to the DRT.

The Appeal filed by the Company will be heard and decided in due course by the Hon'ble DRAT.

**Notes to the Financial Statements****Note: 41 - Financial Risk Management:- Continued****B Risk Management:**

The Company's activities expose it to market risk, liquidity risk, interest risk and credit risk. This note explains the sources of risk which the entity is exposed to and how the entity manages the risk and the related impact in the financial statements.

Risk Management is embedded in the company's operating framework. The Audit Committee of the Board evaluates the Risk Management systems and the Board takes responsibility for the total process of Risk Management in the organization, which includes framing, implementing and monitoring Risk Management Plan.

The Company does not actively engage in the trading of financial assets for speculative purposes nor does it write options.

The most significant financial risks to which the Company is exposed are described below:

**a Credit risk:**

Credit risk arises from the possibility that customer may not be able to settle its obligations as agreed. The Company is exposed to credit risk in the event of non-payment by customers for the installments due as per the contracts with the customers. Such receivables are subject to continuous monitoring and regular follow-up. Possession of the units is handed over to customer only after the entire consideration is received from the customers, hence the credit risk is insignificant.

The Company periodically assesses the financial reliability of the counter party taking into account the financial condition, current economic trends, analysis of historical bad debts and ageing of accounts receivable. Party-wise credit is monitored and reviewed accordingly.

**Bank deposits:**

The company maintains its Cash and cash equivalents and Bank deposits with reputed and highly rated banks. Hence, there is no significant credit risk on such deposits.

**Trade Receivable:**

The Company is exposed to credit risk in the event of non-payment by customers. Major part of sales is made on 'Delivery against payment' basis, hence the credit risk is insignificant. To eliminate credit risk further, high value sales are made by adequate coverage through Letters of Credit, wherever possible, or against post-dated cheques. Clean credit is extended only in exceptional cases. The Company trades with recognized and credit worthy customers. It is the Company's policy that all customers who wish to trade on credit terms are subjected to scrutiny and periodic review. In addition, receivable balances are monitored on an on-going basis with the result that the Company's exposure to bad debts is not significant.

Further, credit risk concentration with respect to trade receivables is mitigated by the Company's large customer base, widely distributed both economically and geographically. Adequate expected credit losses are recognized as per the assessments based on historic data and prevalent market conditions.

Against doubtful trade receivables of ₹ 60 Lacs (Previous year - ₹ 45 Lacs), allowance for doubtful receivables is ₹ 60 Lacs as at March 31, 2026 (Previous year - ₹ 45 Lacs).

**c Interest rate risk:**

Interest rate risk is the risk that the fair value of future cash flow of the financial instrument may fluctuate because of change in market interest rates.

The Company's policy is to minimise interest rate cash flow risk exposures on long-term financing. As at March 31, 2026, the Company is not exposed to changes in market interest rates through borrowings as all its borrowings are at fixed interest rate. Also, the Company opts for investments in Fixed Deposits at fixed interest rates.

**d Price risk:**

The Company has no significant exposure to price risk arising from investments in mutual funds, as the investments are usually in debt funds. Investing in equity shares of companies is based on the concept of value investing. While these investments are subject to various risks, stringent norms for investment decisions are in place for minimising risks associated to such investments.

**Note: 43 - Social Security, 2020 ('Code') - New Labour Codes:**

On November 21, 2025, the Government of India notified and brought into effect the four Labour Codes, namely the Code on Wages, 2019, the Code on Social Security, 2020, the Industrial Relations Code, 2020 and the Occupational Safety, Health and Working Conditions Code, 2020, which, inter alia, introduced a revised definition of "wages" and rationalise various employee-related legislations. Based on the available information, including revised Labour Codes, draft rules, clarifications and FAQs issued by the Ministry of Labour and Employment, the Company has assessed the impact of revision in the definition of wages as per the new Codes and has accounted for additional past service cost of ₹ 29 lacs, based on actuarial valuation of gratuity liability, which has been treated as part of employee cost. The Company continues to monitor the finalisation of Central and State Rules and any further clarifications issued by the Government, and will account for additional impact, if any, in the period in which such changes become effective.

**Note: 1 - Corporate Information:**

Ashima Limited is engaged in Real Estate business and Investment activity.

The Company has two ongoing Real Estate projects on hand. The first project of the Company, “Swan Lake” is a weekend homes project on the western outskirts of Ahmedabad city, spanning on about 90 acres. It features a lavish, fully equipped clubhouse and thoughtfully designed amenities for recreation and relaxation, all nestled in meticulously landscaped greenery.

The other project is ‘The Sovereign’, a luxurious residential project with 102 exclusive residences in a 430 ft. tall tower having 37 floors. It offers meticulously designed amenities and facilities tailored for residents’ comfort, situated in a high-end neighbourhood in west Ahmedabad.

The Company has a wholly owned subsidiary, named Ashima Capital Management Limited (“ACML”), which is engaged in portfolio management activity as a SEBI-Registered Portfolio Manager under SEBI (PMS) Regulations. ACML is managing portfolios of various entities, including that of Ashima Limited, with assets under management of ₹ 302 Crs as on the Balance Sheet date.

The company is a public company domiciled in India and is incorporated under the provisions of the Companies Act, 1956 (now Companies Act, 2013) (“the Act”). Its shares are listed on the Bombay Stock Exchange (BSE Limited) and the National Stock Exchange (National Stock Exchange of India Limited) in India. The registered office of the company is located at 1st Floor, “Aditya”, Near Khadayata Colony, Ellisbridge, Ahmedabad - 380006.

The financial statements for the year ended March 31, 2026 were authorised for issue in accordance with a resolution of the directors passed at their meeting held on May 23, 2026.

**Note: 2 - Material Accounting Policies:**

The following note provides list of the material accounting policies adopted in the preparation of these financial statements.

These policies have been consistently applied to all the years presented unless otherwise stated.

**1 Basis of preparation:**

- A** The Consolidation Financial Statements of the Group are prepared in accordance with Indian Accounting Standards (Ind AS) as per the Companies (Indian Accounting Standards) Rules, 2015 and the subsequent amendments from time to time, notified under Section 133 of the Companies Act, 2013 (the “Act”) and other relevant provisions of the Act. The accounting policies have been consistently applied by the Group and are consistent with those used in the previous year.

These Consolidated Financial Statements of the Group as at and for the year ended March 31, 2026 (including comparatives) were approved and authorised for issue by the Board of Directors of the Company on May 23, 2026.

**B Basis of Measurement :**

Group’s Consolidation Financial Statements have been prepared on historical cost convention except certain financial assets and liabilities which are measured at fair value or revalued amount:

- i** Derivative financial instruments
- ii** Certain financial assets and liabilities measured at fair value [refer accounting policy regarding financial instruments]
- iii** Defined benefit plans
- iv** Certain items of Property, Plant and Equipment

**C Basis of Consolidation**

The financial statements of the subsidiary have been consolidated with the financial statements of the Company in accordance with the requirements of Ind AS 110 – Consolidated Financial Statements.

The intercompany balances, transactions, income, and expenses have been eliminated in the consolidation process.

- (i) The Consolidated Financial Statements incorporate the financial statements of the Parent Company and its subsidiaries. For this purpose, an entity which is, directly or indirectly, controlled by the Parent Company is treated as subsidiary. The Parent Company together with its subsidiaries constitute the Group. Control exists when the Parent Company, directly or indirectly, has power over the investee, is exposed to variable returns from its involvement with the investee and has the ability to use its power to affect its returns.
- (ii) The Consolidated Financial Statements of the Group combines financial statements of the Parent Company and its subsidiaries line-by-line by adding together the like items of assets, liabilities, income and expenses. All intragroup assets, liabilities, income, expenses and unrealised profit/losses on intra-group transactions are eliminated on consolidation. The accounting policies of subsidiaries have been harmonised to ensure the consistency with the policies adopted by the Parent Company. The Consolidated Financial Statements have been presented to extent possible, in a same manner as Parent Company's Standalone Financial Statements.

**2 Use of Estimates:**

The preparation of the financial statements in conformity with Ind AS requires management to make estimates, judgments and assumptions. These estimates, judgments and assumptions affect the application of accounting policies and the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities at the date of the financial statements and reported amounts of income and expenses during the period. Application of accounting policies that require critical accounting estimates involving complex and subjective judgments are provided below.

Accounting estimates could change from period to period. Actual results could differ from those estimates. Appropriate changes in estimates are made as management becomes aware of changes in circumstances surrounding the estimates. Changes in estimates are reflected in the financial statements in the period in which changes are made and, if material, their effects are disclosed in the notes to the financial statements.

**a Critical estimates and judgments**

Determination of revenue under the satisfaction of performance obligation necessarily involves making estimates, some of which are of a technical nature, concerning, where relevant, the timing of satisfaction of performance obligation, costs to completion for the project or activity and the foreseeable losses to completion. Estimates of project income, as well as project costs, are reviewed periodically. The Company recognises revenue when the Company satisfies its performance obligation.

**b Income Taxes:**

Significant judgments are involved in determining the provision for income taxes, including amount expected to be paid/ recovered for uncertain tax positions, and in estimation of deferred tax asset or liability.

**c Property, plant and equipment:**

Property, plant and equipment represent a significant proportion of the asset base of the

Company. The charge in respect of periodic depreciation is derived after determining an estimate of an asset's expected useful life and the expected residual value at the end of its life. Management reviews the residual values, useful lives and methods of depreciation of property, plant and equipment at reasonable intervals and any revision to these is recognised prospectively in current and future periods. The useful lives are based on historical experience with similar assets as well as anticipation of future events, which may affect their life, such as changes in technology.

Significant judgments are involved in determining the estimated future cash flows and/or net realisable value from the property, plant and equipment to determine its value in use to assess whether there is any impairment in its carrying amount as reflected in the financials.

**d Employee Benefits:**

Significant judgments are involved in making estimates about the life expectancy, discounting rate, salary increase, etc. which significantly affect the working of the present value of future liabilities on account of employee benefits by way of defined benefit plans.

**e** Significant judgment is involved in making estimate about the fair value of the non-convertible debentures issued by the company on which no interest is payable and which are to be redeemed at a premium which is calculated based on project IRR as per terms of the debentures.

**f Product quality claims:**

Significant judgments are involved in determining estimated value of likely product quality claims.

**g Insurance claims:**

Significant judgments are involved in determining estimated value likely to be received in respect of insurance claims lodged in respect of loss/damage to properties/stock of the company.

**3 Non-Current assets (or disposal groups) held for sale**

Non-Current assets and disposal groups are classified as held for sale if their carrying amount will be recovered principally through a sale transaction rather than through continuing use. This condition is regarded as met only when the asset (or disposal group) is available for immediate sale in its present condition subject only to terms that are usual and customary for sales of such asset (or disposal group) and its sale is highly probable. Management must be committed to the sale, which should be expected to qualify for recognition as a completed sale within one year from the date of classification.

Non-Current assets (and disposal groups) classified as held for sale are measured at the lower of their carrying amount and fair value less costs to sell except for those assets that are specifically exempt under relevant Ind AS. Once the assets are classified as "Held for sale", those are not subjected to depreciation till disposal.

An impairment loss is recognised for any initial or subsequent write-down of the asset (or disposal group) to fair value less costs to sell. A gain is recognised for any subsequent increases in fair value less costs to sell of an asset (or disposal group), but not in excess of any cumulative impairment loss previously recognised.

A gain or loss not previously recognised by the date of the sale of the non-current asset (or disposal group) is recognised at the date of derecognition.

Non-current assets classified as held for sale and the assets of a disposal group classified as held for sale are presented separately from the other assets in the balance sheet.

**4 Discontinued operation:**

A discontinued operation is a component of an entity that either has been disposed of, or is classified as held for sale and that represents a separate line of business or geographical area of operations, is part of single coordinated plan to dispose of such a line of business or area of operations, or is a subsidiary acquired exclusively with a view to resale. The results of discontinued operations are presented separately in the statement of profit and loss.

**5 Foreign Currency Transactions:**

- A** The Company's financial statements are presented in Indian Rupees (₹), which is the functional and presentation currency.
- B** The transactions in foreign currencies are translated into functional currency at the rates of exchange prevailing on the dates of transactions.
- C** Foreign Exchange gains and losses resulting from settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at the year-end exchange rates are recognised in the Statement of Profit and Loss.
- D** Foreign exchange differences regarded as an adjustment to borrowing costs are presented in the Statement of Profit and Loss as part of finance costs. All the other foreign exchange gains and losses are presented in the Statement of Profit and Loss on a net basis.

**6 Revenue Recognition:**

- A** Revenue is recognised to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be reliably measured, regardless of when the payment is being made. Revenue is measured at the fair value of the consideration received or receivable, taking into account contractually defined terms of payment and excluding taxes or duties collected on behalf of the government and is shown net of returns, trade allowances, rebates, volume discounts and value added taxes. The Company derives revenues primarily from sale of manufactured goods, traded goods and related services. The Company is also engaged in real estate property development. Revenue is recognized on satisfaction of performance obligation upon transfer of control of promised products or services to customers in an amount that reflects the consideration the Company expects to receive in exchange for those products or services.
- B** In determining the transaction price, the Company considers the effects of variable consideration and the existence of significant financing components, if any.
- C** GST is not received by the Company on its own account, but is tax collected on value added to the goods/ services by the Company on behalf of the government. Accordingly, it is excluded from revenue.
- D** For revenue to be recognised, the following specific recognition criteria for each types of revenue must be satisfied:
  - a Sale of Goods:**

Revenue from the sale of goods is recognised when the control of the goods has passed to the buyer, usually on delivery of the goods. Revenue from the sale of goods is measured at the fair value of the consideration received or receivable, net of returns, trade allowances, rebates, volume discounts and GST.

The goods are often sold with volume discounts/pricing incentives and customers have a right to return defective products. Revenue from sales is based on the price in the sales contracts, net of discounts. Historical experience is used to estimate and provide for customer claims. No element of financing is deemed present, as the sales are made with the normal credit terms as per prevalent trade practice and credit policy followed by the Company.

**b Real Estate Transactions:**

The Company satisfies a performance obligation and recognises revenue over time, if one of the following criteria is met:

1. The customer simultaneously receives and consumes the benefits provided by the Company's performance as the Company performs.
2. The Company's performance creates or enhances an asset that the customer controls as the asset is created or enhanced; or
3. The Company's performance does not create an asset with an alternative use to the Company and the entity has an enforceable right to payment for performance completed to date.

For performance obligations where none of the above conditions are met, revenue is recognised at the point in time at which the performance obligation is satisfied.

Revenue in excess of invoicing are classified as contract asset, while invoicing in excess of revenues are classified as contract liabilities.

**c Service Income:**

Service income is recognised as per the terms of contracts with the customers when the related services are performed and are net of GST, wherever applicable.

**d Portfolio Management and allied services Fees:**

The fees are a series of similar services and a single performance obligation satisfied over a period of time. These are billed on a monthly / quarterly basis. The fees are recognised when outcome of a transaction can be estimated reliably by reference to the stage of completion of the transaction.

**e Interest Income:**

For all debt instruments measured at amortized cost, interest income is recorded using the effective interest rate (EIR). EIR is the rate that exactly discounts the estimated future cash payments or receipts over the expected life of the financial instrument or a shorter period, where appropriate, to the gross carrying amount of the financial asset or to the amortized cost of a financial liability. When calculating the effective interest rate, the Company estimates the expected cash flows by considering all the contractual terms of the financial instrument, but does not consider the expected credit losses.

- f** Claims receivable on account of Insurance are accounted for to the extent the Company is reasonably certain of their ultimate collection.

**g Dividend Income:**

Dividend Income is recognized when the right to receive the same is established.

**h Other Income:**

Other income is recognised when no significant uncertainty as to its determination or realisation exists.

**7 Taxes on Income:**

Tax expenses comprise of current and deferred tax.

**A Current Tax:**

- a** Current tax is measured at the amount expected to be paid on the basis of reliefs and deductions available in accordance with the provisions of the Income Tax Act, 1961. The tax rates and tax laws used to compute the amount are those that are enacted or substantively enacted, at the reporting date.
- b** Current tax items are recognised in correlation to the underlying transaction either in Statement of Profit and Loss, Other Comprehensive Income (OCI) or directly in equity.
- c** Management periodically evaluates positions taken in the tax returns with respect to situations in which applicable tax regulations are subject to interpretation and establishes provisions where appropriate.

**B Deferred Tax:**

- a** Deferred tax is provided using the liability method on temporary differences between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes at the reporting date.
- b** Deferred tax liabilities are recognised for all taxable temporary differences.
- c** Deferred tax assets are recognised for all deductible temporary differences and carry forward of unused tax losses.  
  
Deferred tax assets are recognised to the extent it is probable that taxable profit will be available against which the deductible temporary differences and carry forward of unused tax losses can be utilized.
- d** The carrying amount of deferred tax assets is reviewed at each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilized. Unrecognised deferred tax assets are re-assessed at each reporting date and are recognised to the extent that it has become probable that future taxable profits will allow the deferred tax asset to be recovered.
- e** Deferred tax assets and liabilities are measured at the tax rates (and tax laws) that have been enacted or substantively enacted at the reporting date and are expected to apply in the year when the asset is realised or the liability is settled.
- f** Deferred tax items are recognised in correlation to the underlying transaction either in Statement of Profit and Loss, Other Comprehensive Income (OCI) or directly in equity.
- g** Deferred tax assets and deferred tax liabilities are offset if a legally enforceable right exists to set off current tax assets against current tax liabilities.

**8 Property, Plant and Equipment:**

- A** Property, Plant, and Equipment including leasehold land existing as on January 1, 2005 have been carried at revalued figures and subsequent additions thereto are accounted for on actual/historical cost basis. Cost includes related expenditure and pre-operative and project expenses for the period upto completion of construction / upto date of assets being ready for its intended use, if recognition criteria are met and the present value of the expected cost for the decommissioning of an asset after its use is included in the cost of the respective asset if the recognition criteria for a provision are met. Cost is reduced by accumulated depreciation and impairment and amount representing assets

discarded or held for disposal. On transition to Ind AS as on April 1, 2016, the Company has elected to measure its Property, Plant and Equipment at carrying value as per previous GAAP. As per the requirement of paragraph 11 of Ind AS 101, outstanding amount in the revaluation reserve was transferred to retained earning account upon transition to Ind AS, since the Company is no longer applying the revaluation model of Ind AS 16 upon transition and has elected to apply the cost model approach.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. All other repairs and maintenance are charged to the Statement of Profit and Loss during the reporting period in which they are incurred.

- B** Where components of an asset are significant in value in relation to the total value of the asset as a whole, and they have substantially different economic lives as compared to principal item of the asset, they are recognised separately as independent items and are depreciated over their estimated economic useful lives.
- C** Depreciation on tangible assets is provided on "straight line method". Useful life of tangible assets except buildings as per following details are different from that prescribed in Schedule II of the Act, which have been arrived at based on technical evaluation. The management believes that these estimated useful lives are realistic and reflect fair approximation of the period over which the assets are likely to be used. However, management reviews the residual values, useful lives and methods of depreciation of property, plant and equipment at reasonable intervals. Any revision to these is recognized prospectively in current and future periods.

- D** Depreciation on impaired assets is calculated on its reduced value, if any, on a systematic basis over its remaining useful life.
- E** Depreciation on additions/ disposals of the property, plant & equipment during the year is provided on pro-rata basis according to the period during which assets are used.
- F** Capital work in progress is stated at cost less accumulated impairment loss, if any. All other repair and maintenance costs are recognised in Statement of Profit or Loss as incurred, unless they meet the recognition criteria for capitalisation under property, plant and equipment.
- G** An item of property, plant and equipment and any significant part thereof initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on de-recognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the Statement of Profit and Loss when the asset is derecognised.

**9 Leases**

**A** The Company has adopted Ind AS 116 “Leases” using the modified retrospective approach, initially applying this standard from April 1, 2019. Accordingly, the information presented for previous year ended March 31, 2019, is not restated and reported as per Ind AS 17.

**B** The Company evaluates if an arrangement qualifies to be a lease as per the requirements of Ind AS 116 and this may require significant judgment. The Company also uses significant judgment in assessing the lease term (including anticipated renewals) and the applicable discount rate.

The Company determines the lease term as the non-cancellable period of a lease, together with both periods covered by an option to extend or terminate the lease if the Company is reasonably certain based on relevant facts and circumstances that the option to extend or terminate will be exercised. If there is a change in facts and circumstances, the expected lease term is revised accordingly.

The discount rate is generally based on the interest rate specific to the lease being evaluated or if that cannot be easily determined the incremental borrowing rate for similar term is used.

The Company has elected not to recognise right-of-use assets and lease liabilities for short-term leases that have a lease term of 12 months or less and leases of low-value assets. The Company recognises the lease payments associated with these leases as an expense on a straight-line basis over the lease term.

The lease liability is initially measured at the present value of the lease payments that are not paid at the commencement date, discounted using the Company’s incremental borrowing rate. It is remeasured when there is a change in future lease payments arising from a change in an index or rate, or a change in the estimate of the amount expected to be payable under a residual value guarantee, or a change in the assessment of whether it will exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the amount of the right-of-use asset, or is recorded in the Statement of Profit and Loss if the carrying amount of the right-of-use asset has been reduced to zero. The right of-use asset is measured by applying cost model i.e. right-of-use asset at cost less accumulated depreciation /impairment losses (Refer note no. 13 for impairment).

**C The Company as a lessee:**

The Company recognises a right-of-use asset and a lease liability at the lease commencement date. The right-of-use asset is initially measured at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or before the commencement date, plus any initial direct costs incurred and restoration cost, less any lease incentives received.

The right-to-use assets are subsequently depreciated over the shorter of the asset’s useful life and the lease term on a straight-line basis. In addition, the right-to-use asset is reduced by impairment losses, if any.

The lease liability is initially measured at amortised cost at the present value of the future lease payments. When a lease liability is remeasured, the corresponding adjustment of the lease liability is made to the carrying amount of the right-of-use asset, or is recorded in the Statement of Profit and Loss, if the carrying amount of the right-to-use asset has been reduced to zero.

The right to use appears as part of fixed assets and the lease liability appears as non current and current liability in the Balance Sheet.

Rent concessions are accounted for as per provisions of the revised Ind-AS 116 “Leases”.

**10 Intangible Assets:**

- A** Intangible assets acquired separately are measured on initial recognition at cost. Following initial recognition, intangible assets are carried at cost less any accumulated amortisation and accumulated impairment losses.
- B** Capitalised cost incurred towards purchase/ development of software is amortized using straight line method over its useful life of six years as estimated by the management at the time of capitalisation.
- C** An item of intangible asset initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on de-recognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the Statement of Profit and Loss when the asset is derecognised.

**11 Borrowing Costs:**

- A** Borrowing costs consist of interest and other borrowing costs that are incurred in connection with the borrowing of funds. Other borrowing costs include ancillary charges at the time of acquisition of a financial liability, which is recognised as per EIR method. Borrowing costs also include exchange differences to the extent regarded as an adjustment to the borrowing costs.
- B** Borrowing costs that are directly attributable to the acquisition / construction of a qualifying asset are capitalised as part of the cost of such assets, up to the date the assets are ready for their intended use.
- C** For capitalization of eligible borrowing costs which are not specifically attributable to the acquisition, construction or production of a particular qualifying asset, a weighted average capitalization rate is applied for all the eligible assets.

The weighted average rate is considered of the borrowing costs applicable to the outstanding borrowings of the company during the period, other than borrowings made specifically for the purpose of obtaining a qualifying asset.

**12 Impairment of Assets:**

The carrying amounts of Property, Plant and Equipment and intangible assets are reviewed at each balance sheet date if there is any indication of impairment based on internal/external factors. An impairment loss is recognized wherever the carrying amount of an asset exceeds its recoverable amount. The recoverable amount is the greater of the asset's net selling price and value in use. In assessing value in use, the Company measures it on the basis of discounted estimated cash flows for the remaining years (remaining useful life). Assessment is also done at each Balance Sheet date as to whether there is any indication that an impairment loss recognized for an asset in prior accounting periods may no longer exist or may have decreased. After impairment, depreciation is provided on the revised carrying amount of the asset over its remaining useful life.

**13 Inventories:**

- A** Inventories are valued at the lower of cost and net realisable value ("NRV"). NRV represents the estimated selling price in the ordinary course of business, less the estimated costs of completion and the estimated costs necessary to make the sale.
- B** The cost of inventories comprises direct expenditure related to real estate activities and other expenditures to the extent that such expenditures are directly attributable to bringing the asset to its working condition for its intended use.

- C** Work-in-progress represents costs incurred in respect of unsold areas of real estate projects or costs incurred on projects for which revenue recognition criteria have not yet been met.

**14 Cash and Cash Equivalents:**

Cash and Cash equivalents for the purpose of Cash Flow Statement comprise cash and cheques in hand, bank balances, demand deposits with banks where the original maturity is three months or less and other short term highly liquid investments.

**15 Provisions, Contingent Liabilities, Contingent Assets and Commitments:**

- A** Provisions are recognised when the Company has a present obligation as a result of past events and it is probable that the outflow of resources will be required to settle the obligation and in respect of which reliable estimates can be made.

When the company expects some or all of a provision to be reimbursed, for example, under an insurance contract, the reimbursement is recognised as a separate asset, but only when the reimbursement is virtually certain. A disclosure for contingent liability is made when there is a possible obligation, that may, but probably will not require an outflow of resources. When there is a possible obligation or a present obligation in respect of which the likelihood of outflow of resources is remote, no provision/ disclosure is made. Contingent Liabilities are not recognised but are disclosed separately in the financial statements. Commitments include the amount of purchase order (net of advances) issued to parties for completion of assets. Provisions, contingencies and commitments are reviewed at each balance sheet date and adjusted to reflect the correct management estimates.

- B** If the effect of the time value of money is material, provisions are discounted using a current pre-tax rate that reflects, when appropriate, the risks specific to the liability.

**16 Provision for Product Quality Claims:**

Provisions for claims raised by customers for products sold by the company are made on management estimates based on claim history and other relevant factors. The initial estimate of the claim is revised at each reporting period.

**17 Employee Benefits:**

**A Short term obligations:**

Liabilities for wages and salaries, including leave encashments that are expected to be settled wholly within 12 months after the end of the period in which the employees render the related service are recognised in respect of employees' services up to the end of the reporting period and are measured by the amounts expected to be paid when the liabilities are settled. The liabilities are presented as current employee benefit obligations in the balance sheet.

**B Long term employee benefits obligations:**

**a Defined Benefit Plans:**

**i Gratuity:**

Liability on account of gratuity is provided for on the basis of actuarial valuation carried out by an independent actuary as at the balance sheet date. The contribution towards gratuity liability is funded to an approved gratuity fund and the funds are managed by insurance companies. The liability or asset recognised in the balance sheet in respect of defined benefit gratuity plan is the present value of the defined benefit plan obligation at the end of the reporting period less the fair value of the plan assets. The liability

with regard to the gratuity Plan is determined by actuarial valuation, performed by an independent actuary, at each balance sheet date using the projected unit credit method. The present value of the defined benefit obligation denominated in ₹ is determined by discounting the estimated future cash outflows by reference to the market yields at the reporting period on government bonds that have terms approximating to the terms of the related obligation.

The net interest cost is calculated by applying the discounting rate to the net balance of the defined benefit obligation and the fair value of plan assets. Such costs are included in employee benefit expenses in the Statement of Profit and Loss. Re-measurements gains or losses arising from experience adjustments and changes in actuarial assumptions are recognised immediately in the period in which they occur directly in "other comprehensive income" and are included in retained earnings in the statement of changes in equity and in the balance sheet.

Re-measurements gains or losses recognized in the other comprehensive income are not reclassified to profit or loss in subsequent periods.

The Company recognises the following changes in the net defined benefit obligation as an expense in the Statement of Profit and Loss:

- i Service costs comprising current service costs and past service costs.
- ii Net interest expense or income.

**b Defined Contribution Plans**

Contribution to provident fund is made to the provident fund administered by the Government and is recognised as employee benefit expenses on accrual basis.

Contribution to National Pension Scheme "NPS", which is also a defined contribution plan, is made to NPS managed by insurance Company and is recognised as employee benefit expenses on accrual basis.

**C Employee Separation Costs:**

The compensation paid to the employees under Voluntary Retirement Scheme is expensed on accrual basis.

**18 Financial Instruments:**

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity.

**A Financial assets:**

**a Initial recognition and measurement:**

All financial assets are recognised initially at fair value plus in the case of financial assets not recorded at fair value through profit or loss, transaction costs that are attributable to the acquisition of the financial asset. Purchases or sales of financial assets that require delivery of assets within a time frame established by regulation or convention in the market place (regular way trades) are recognised on the settlement date, i.e., the date that the Company settles to purchase or sell the asset.

**b Subsequent measurement:**

For purposes of subsequent measurement, financial assets are classified in following categories:

**i Financial Assets at amortized cost:**

A 'financial asset' is measured at the amortized cost if both the following conditions are met:

- The asset is held with an objective of collecting contractual cash flows.
- Contractual terms of the asset give rise on specified dates to cash flows that are "solely payments of principal and interest" (SPPI) on the principal amount outstanding.

After initial measurement, such financial assets are subsequently measured at amortized cost using the effective interest rate (EIR) method. Amortized cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortisation is included in finance income in the Statement of Profit and Loss. The losses arising from impairment are recognised in the Statement of Profit or Loss. This category generally applies to trade and other receivables.

**ii Financial Assets at fair value through other comprehensive income (FVTOCI):**

A 'financial asset' is classified as at the FVTOCI if both of the following criteria are met:

- The asset is held with objective of both - for collecting contractual cash flows and selling the financial assets.
- The asset's contractual cash flows represent SPPI.

Financial Assets included within the FVTOCI category are measured initially as well as at each reporting date at fair value. Fair value movements are recognized in the OCI. However, the Company recognizes interest income, impairment losses and reversals and foreign exchange gain or loss in the Statement of Profit and Loss. On Derecognition of the asset, cumulative gain or loss previously recognised in OCI is reclassified from the equity to Statement of Profit and Loss. Interest earned whilst holding FVTOCI financial asset is reported as interest income using the EIR method.

**iii Financial Assets and derivatives at fair value through profit or loss (FVTPL):**

FVTPL is a residual category for financial assets. Any financial asset, which does not meet the criteria for categorization as at amortized cost or as FVTOCI, is classified as at FVTPL.

Assets included within the FVTPL category are measured at fair value with all changes recognized in the Statement of Profit and Loss.

**c Derecognition:**

A financial asset (or, where applicable, a part of a financial asset) is primarily derecognised when:

- i The right to receive cash flows from the asset has expired, or
- ii The Company has transferred its right to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a 'pass-through' arrangement and either

(a) the Company has transferred substantially all the risks and rewards of the asset, or (b) the Company has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Company has transferred its right to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if and to what extent it has retained the risks and rewards of ownership. When it has neither transferred substantially all of the risks and rewards of the asset, nor transferred control of the asset, the Company continues to recognise the transferred asset to the extent of the Company's continuing involvement. In that case, the Company also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Company has retained. When the Company has transferred the risk and rewards of ownership of the financial asset, the same is derecognised.

**d Impairment of financial assets:**

In accordance with Ind AS 109, the Company applies expected credit loss (ECL) model for measurement and recognition of impairment loss on the following financial assets and credit risk exposure:

- a** Financial assets that are debt instruments, and are measured at amortized cost.
- b** Trade receivables or any contractual right to receive cash or another financial asset.
- c** Financial assets that are debt instruments and are measured at FVTOCI.

The Company follows 'simplified approach' for recognition of impairment loss allowance on Point c provided above. The application of simplified approach does not require the Company to track changes in credit risk. Rather, it requires the company to recognise the impairment loss allowance based on lifetime ECLs at each reporting date, right from its initial recognition. For recognition of impairment loss on other financial assets and risk exposure, the Company determines whether there has been a significant increase in the credit risk since initial recognition. If credit risk has not increased significantly, 12-month ECL is used to provide for impairment loss. However, if credit risk has increased significantly, lifetime ECL is used. If, in a subsequent period, credit quality of the instrument improves such that there is no longer a significant increase in credit risk since initial recognition, then the entity reverts to recognising impairment loss allowance based on 12-month ECL.

Lifetime ECL are the expected credit losses resulting from all possible default events over the expected life of a financial instrument. The 12-month ECL is a portion of the lifetime ECL which results from default events that are possible within 12 months after the reporting date.

ECL is the difference between all contractual cash flows that are due to the Company in accordance with the contract and all the cash flows that the entity expects to receive (i.e., all cash shortfalls), discounted at the original EIR. ECL impairment loss allowance (or reversal) recognized during the period is recognized as income/ expense in the Statement of Profit and Loss. The balance sheet presentation for various financial instruments is described below:

- a** Financial assets measured as at amortized cost and contractual revenue receivables: ECL is presented as an allowance, i.e., as an integral part of the measurement of those assets in the balance sheet, which reduces

the net carrying amount. Until the asset meets write-off criteria, the Company does not reduce impairment allowance from the gross carrying amount.

- b** Financial guarantee contracts: ECL is presented as a provision in the balance sheet, i.e. as a liability.

For assessing increase in credit risk and impairment loss, the Company combines financial instruments on the basis of shared credit risk characteristics.

### **B Financial liabilities:**

#### **a Initial recognition and measurement:**

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, payables, or as derivatives designated as hedging instruments in an effective hedge, as appropriate. All financial liabilities are recognised initially at fair value and, in the case of loans, borrowings and payables, net of directly attributable transaction costs.

#### **b Subsequent measurement:**

Subsequently, all financial liabilities are measured as amortized cost except for financial guarantee contracts, as described below:

##### **i Loans and borrowings:**

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortized cost using the EIR method. Gains and losses are recognised in Statement of Profit or Loss when the liabilities are derecognised as well as through the EIR amortisation process. Amortized cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortisation is included as finance costs in the Statement of Profit and Loss.

Non interest-bearing non-convertible redeemable Debentures issued by the company, which are to be redeemed at a premium which is calculated based on project IRR as per terms of debentures, are subsequently measured at fair value through profit and loss (FVTPL).

#### **c Derecognition:**

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognised in the Statement of Profit and Loss.

### **C Reclassification of financial assets:**

The Company determines classification of financial assets and liabilities on initial recognition. After initial recognition, no reclassification is made for financial assets which are equity instruments and financial liabilities. For financial assets which are debt instruments, a reclassification is made only if there is a change in the business model for managing those assets. Changes to the business model are expected to be infrequent. The Company's senior management determines change in the business model as a result of external or internal changes which are significant to the Company's operations. If the Company reclassifies financial assets, it applies the reclassification prospectively

from the reclassification date, which is the first day of the immediately next reporting period following the change in business model as per Ind AS 109.

**D Offsetting of financial instruments:**

Financial assets and financial liabilities are offset and the net amount is reported in the balance sheet if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, to realise the assets and settle the liabilities simultaneously.

**19 Derivative Financial Instruments:**

Derivatives are recognised initially at fair value and subsequently at fair value through profit and loss.

**20 Earnings per Share:**

Basic earnings per share are calculated by dividing the net profit or loss (excluding other comprehensive income) for the year attributable to equity shareholders by the weighted average number of equity shares outstanding during the year. The weighted average number of equity shares outstanding during the year is adjusted for events such as bonus issue, bonus element in a right issue, shares split and reverse share splits (consolidation of shares) that have changed the number of equity shares outstanding, without a corresponding change in resources. For the purpose of calculating diluted earnings per share, the net profit or loss (excluding other comprehensive income) for the year attributable to equity shareholders and the weighted average number of shares outstanding during the year are adjusted for the effects of all dilutive potential equity shares.

**Note: 3 - Recent pronouncements:**

The Ministry of Corporate Affairs ("MCA") notifies new standards or amendments to the existing standards under Companies (Indian Accounting Standards) Rules as issued from time to time. During the year ended March 31, 2026, MCA has notified Ind AS 1 - Classification of liabilities as Current or Non-Current, Ind AS 7 - Disclosure of Supplier Finance Arrangements, Ind AS 12 – International Tax Reform (Pillar Two Model Rules) and amendments to Ind AS 21 – Lack of Exchangeability, applicable to the Company w.e.f. April 1, 2026. The Company has reviewed the new pronouncements and based on its evaluation has determined that it does not have any significant impact in its financial statement.

**A Securities and Terms of Repayment for Secured Long Term Borrowings:****A Preference Shares**

- i. 1% redeemable non-cumulative preference shares of ₹ 100/- each fully paid to be redeemed at par at the end of 20 years from the date of allotment. The Company has an option to redeem the preference shares at par at any time after the end of 12 months from the date of allotment.

**ii. Rights of Preference Share holders :**

- (a) As per Section 47(2) of the Companies Act, 2013, Preference Shareholders shall have right to vote only on resolutions placed before company which directly affect their rights attached to preference shares and any resolution for winding up of the company or for repayment or reduction of share capital shall be deemed directly to affect their rights.
- (b) Voting rights of the preference shareholders shall be in the same proportion as the paid up preference share capital bears to the paid up equity share capital.
- (c) Where the dividend in respect of a class of preference shares has not been paid for a period of two years or more, such class of preference shareholders shall have a right to vote on all the resolutions placed before the company.

**B Securities and Major Terms of Non-Convertible Debentures**

- (i) The company has issued 5,500 (previous year 4,500) Unlisted, Secured, Unrated, Redeemable, Rupee Denominated, Non-Convertible Debentures ("the debentures") of ₹ 1,00,000/- each on private placement basis to part-finance the Company's Project of High-rise Residential Apartments in the name of 'The Sovereign'.

**Notes to the Consolidated Financial Statements**

During the year, the Company exercised its Call Option for partial redemption of the said debentures not by cancellation of debentures, but by reduction in paid-up value of the existing NCDs. Accordingly, ₹ 2825 Lacs were redeemed during the financial year. As at March 31, 2026, the aggregate outstanding principal of the said debentures stands at ₹ 2675 Lacs.

**Major Terms of the debentures :**

- 1 Security: The debentures are secured by creation of a first charge on the (a) Project Land (b) FSI thereof and the (c) Project put up/ being put up thereon, in favour of debenture trustee for the benefit of the debenture holders by execution and registration of Deed of Mortgage.
  - 2 No interest is payable on the debentures.
  - 3 Redemption and premium on redemption: On the completion of the project or 7 years from the date of allotment of debentures, whichever is earlier, the Company shall redeem the debentures along with premium (if applicable) to be calculated in a manner that the debenture holders receive premium which is equivalent to an IRR on the Debenture Subscription Amount which is equal to the "Project IRR" as specified in the terms of debentures. The premium on redemption, including partial redemptions, will be computed and paid at the end of the tenure of the NCDs. The Company, at any time after completion of 12 months from the date of allotment, shall have an option to partially or fully redeem the debentures.
  - 4 The debentures have been carried at fair value
- (ii) The Company had issued 5,000 (previous year 5,000) Unlisted, Secured, Unrated, Redeemable, Rupee Denominated, Non-Convertible Debentures ("the debentures") of ₹ 1,00,000/- (Rupees One Lac only) each on private placement basis for financing the working capital requirements of the Company. During the year, the Company exercised its Call Option for early redemption of the said debentures. Accordingly, 4,500 NCDs aggregating to ₹ 4500 Lacs were redeemed on July 14, 2025 and the balance 500 NCDs aggregating to ₹ 500 Lacs were redeemed on September 2, 2025. With the aforesaid redemptions, all 5,000 NCDs aggregating to ₹ 5000 Lacs issued to Subahu Enterprises LLP have been fully redeemed during the year and no further NCDs remain outstanding under this series.
- (iii) During the year, the Company has issued 12,000 (previous year Nil) Unlisted, Secured, Unrated, Redeemable, Rupee Denominated, Non-Convertible Debentures ("the debentures") of ₹ 1,00,000/- each on private placement basis, comprising of two tranches - 5,000 NCDs allotted on July 21, 2025 aggregating to ₹ 5000 Lacs and 7,000 NCDs allotted on July 31, 2025 aggregating to ₹ 7000 Lacs aggregating in total to ₹ 12000 Lacs.

**Major Terms of the debentures :**

- 1 Security: The debentures are secured by creation of a first charge on the Non-Agricultural Land in favour of debenture trustee for the benefit of the debenture holder by execution and registration of Deed of Mortgage in compliance with the provisions of applicable laws.
- 2 Interest is payable to debenture holders @ 7.50% per annum, due on March 31, every year.
- 3 Redemption : At the end of 9 (Nine) years from the respective dates of allotment of Debentures with Put Option. The subscriber has a Put Option after the end of 2 (Two) years from the date of allotment, for redemption of Debentures in part or full. In case of any delay in the payment of interest and/or principal amount on the respective due dates, the Issuer shall be liable to pay additional interest at the rate of 1% per annum for the period of delay.
- 4 The debentures have been carried at amortised cost.

**C Unsecured Loan**

The unsecured loans include ₹ 750 Lacs in the suspense account representing amount of a cheque drawn on HDFC Bank given by the company to Bank of Bahrain & Kuwait ("BBK") and amount credited to BBK by RBI clearing house because of the delay by HDFC Bank in returning the cheque to BBK.

The Debt Recovery Tribunal ("DRT"), vide its order dated June 30, 2017 directed BBK (Defendant No. 1) and the Company (Defendant No.2) jointly and severally to pay the suit amount of ₹ 914.23 Lacs with further simple interest @12% per annum on principal amount of ₹ 750 Lacs.

Meanwhile, as part of recovery proceedings filed by HDFC Bank for a decretal amount of ₹ 2070.45 lacs, the Recovery Officer ("RO") passed orders dated March 29, 2019 and April 9, 2019 allowing the application of HDFC Bank for the said decretal amount and inter alia also directed attachment of certain immovable properties of the Company situated at Ahmedabad, Kadi and Mumbai.

The Company filed a writ petition at Hon'ble High Court of Bombay challenging the aforesaid two orders of RO dated March 29, 2019 and April 9, 2019. The Hon'ble Bombay High Court vide an Order dated November 22, 2019 allowed the Company to pursue its said appeal at the Hon'ble DRAT. The Hon'ble High Court also suspended the warrant of attachment against Company's immovable properties and RO's order dated March 29, 2019 till the Company's appeal is decided by the Hon'ble DRAT. The said appeal has been heard and Order dated April 26, 2024 has been passed by the Hon'ble DRAT remanding the matter back to the DRT with directions to consider the question of jurisdiction raised by the Company in the OA together with other issues afresh.

Having taken into consideration the Order passed by the Hon'ble High Court of Bombay and the subsequent Order passed by the Hon'ble DRAT, the Hon'ble Recovery Officer has passed Order on June 19, 2024 for lifting the said attachment on immoveable properties of the Company situated at Ahmedabad, Kadi and Mumbai. At present there is no attachment by DRT on any properties of the Company.

HDFC Bank filed a writ petition at the Hon'ble High Court of Bombay challenging the Order dated April 26, 2024 passed by the Hon'ble DRAT and the Hon'ble High Court of Bombay has by Order dated February 20, 2025 given directions to the Hon'ble DRAT to hear and decide the Appeal filed by the Company without remanding them back to the DRT.

The Appeal filed by the Company will be heard and decided in due course by the Hon'ble DRAT.

The Company provides for gratuity for employees as per the Code on Social Security 2020. The gratuity plan is a funded plan administered by a Trust and the Company makes contributions to recognised Trust. In accordance with Indian Accounting Standard 19, actuarial valuation was done in respect of the aforesaid defined benefit plans based on the following assumptions.

**Economic Assumptions:**

**Notes to the Consolidated Financial Statements****Note: 41 - Financial Risk Management:- Continued****B Risk Management:**

The Company's activities expose it to market risk, liquidity risk, interest risk and credit risk. This note explains the sources of risk which the entity is exposed to and how the entity manages the risk and the related impact in the financial statements.

Risk Management is embedded in the company's operating framework. The Audit Committee of the Board evaluates the Risk Management systems and the Board takes responsibility for the total process of Risk Management in the organization, which includes framing, implementing and monitoring Risk Management Plan.

The Company does not actively engage in the trading of financial assets for speculative purposes nor does it write options.

The most significant financial risks to which the Company is exposed are described below:

**a Credit risk:**

Credit risk arises from the possibility that customer may not be able to settle its obligations as agreed. The Company is exposed to credit risk in the event of non-payment by customers for the instalments due as per the contracts with the customers. Such receivables are subject to continuous monitoring and regular follow-up. Possession of the units is handed over to customer only after the entire consideration is received from the customers, hence the credit risk is insignificant.

The Company periodically assesses the financial reliability of the counter party taking into account the financial condition, current economic trends, analysis of historical bad debts and ageing of accounts receivable. Party-wise credit is monitored and reviewed accordingly.

**Bank deposits:**

The company maintains its Cash and cash equivalents and Bank deposits with reputed and highly rated banks. Hence, there is no significant credit risk on such deposits.

**Trade Receivable:**

The Company is exposed to credit risk in the event of non-payment by customers. Major part of sales is made on 'Delivery against payment' basis, hence the credit risk is insignificant. To eliminate credit risk further, high value sales are made by adequate coverage through Letters of Credit, wherever possible, or against post-dated cheques. Clean credit is extended only in exceptional cases. The Company trades with recognized and credit worthy customers. It is the Company's policy that all customers who wish to trade on credit terms are subjected to scrutiny and periodic review. In addition, receivable balances are monitored on an on-going basis with the result that the Company's exposure to bad debts is not significant.

Further, credit risk concentration with respect to trade receivables is mitigated by the Company's large customer base, widely distributed both economically and geographically. Adequate expected credit losses are recognized as per the assessments based on historic data and prevalent market conditions.

Against doubtful trade receivables of ₹ 60 Lacs (Previous year - ₹ 45 Lacs), allowance for doubtful receivables is ₹ 60 Lacs as at March 31, 2026 (Previous year - ₹ 45 Lacs).

**c Interest rate risk:**

Interest rate risk is the risk that the fair value of future cash flow of the financial instrument may fluctuate because of change in market interest rates.

The Company's policy is to minimise interest rate cash flow risk exposures on long-term financing. As at March 31, 2026, the Company is not exposed to changes in market interest rates through borrowings as all its borrowings are at fixed interest rate. Also, the Company opts for investments in Fixed Deposits at fixed interest rates.

**d Price risk:**

The Company has no significant exposure to price risk arising from investments in mutual funds, as the investments are usually in debt funds. Investing in equity shares of companies is based on the concept of value investing. While these investments are subject to various risks, stringent norms for investment decisions are in place for minimising risks associated to such investments.

On November 21, 2025, the Government of India notified and brought into effect the four Labour Codes, namely the Code on Wages, 2019, the Code on Social Security, 2020, the Industrial Relations Code, 2020 and the Occupational Safety, Health and Working Conditions Code, 2020, which, inter alia, introduced a revised definition of "wages" and rationalise various employee-related legislations. Based on the available information, including revised Labour Codes, draft rules, clarifications and FAQs issued by the Ministry of Labour and Employment, the Company has assessed the impact of revision in the definition of wages as per the new Codes and has accounted for additional past service cost of ₹ 29 lacs, based on actuarial valuation of gratuity liability, which has been treated as part of employee cost. The Company continues to monitor the finalisation of Central and State Rules and any further clarifications issued by the Government, and will account for additional impact, if any, in the period in which such changes become effective.
